1. *Approval of Proposed Budget*. The Proposed Budget submitted to the District Board and attached as <u>Exhibit A</u> hereto is hereby approved and a hearing on the Proposed Budget is hereby ordered as required by law.

2. *Notice of Hearing*. Publication of the notice of the public hearing on the Proposed Budget in the form attached hereto as <u>Exhibit B</u>, which was published in accordance with the provisions of Section 48-716 of the Arizona Revised Statutes, is hereby ratified, approved and adopted.

3. *Effective Date*. This resolution is effective immediately.
