Mayor Manross said detailed records have been kept, and the city has had an ongoing records management program for some time. She clarified that this action would correct some outdated language and help the city do a better job.

28. Issuance of Requests for Proposals (RFPs) for the Possible Development of Four City Owned Parcels in Downtown

Request: Approve the issuance of Requests for Proposals for four City owned parcels in Downtown.

Dave Roderique identified the four sites (Rose Garden Lot, Pepperwood Lot, Stadium Site, and Stetson Lot) and their proposed uses. He detailed the RFP process, which is used as a way to 'test the market' for private sector interest in revitalizing downtown.

Councilman Silverman commented on the need for more reasonably priced housing downtown and wondered if that could be controlled in the RFP process. Mr. Roderique said it could be clearly stated in the RFP by instructing respondents to focus on more affordable housing. The responses could then be chosen based on the type of product they provide.

Responding to Councilman O'Hearn, Mr. Roderique said no formal decision has been made on whether or not to keep the advertising for the RFP local or to go national. There has been a lot

of interest from local developers, so staff would probably start locally to determine the level of interest.

In further clarification, Mr. Roderique said the proposals would be considered preliminary, as the developer would be asked to do a conceptual, rather than a detailed, analysis. It's possible that parking may be structured underground. There will be four separate RFPs with a weighted criteria list. He noted that there might be a need later to go through a more detailed RFP process.

Councilman Littlefield expressed concerns about the process.

Councilman Ortega commented on the need for additional parking, noting the city was looking into alternate zoning (SRO), and the only way to come up with a different product downtown was to come up with another option. He encouraged staff to look at optional zoning categories.

Vice Mayor Ecton stated his belief that it is too early to speculate on the results of the RFPs. He expressed concern about the possible impact on local business owners, although he thought the RFP process would be a good way to get the discussion moving.

Mayor Manross said all locations would need to have high sensitivity to design elements. She explained that she has seen SRO zoning in San Diego and felt it would be worthwhile to look into it for Scottsdale's downtown. She stated her opinion that this action would help in identifying ways to better leverage private investment downtown.

Mayor Manross opened public testimony.

Marilyn Atkinson, 3957 N Brown Av, 85251, expressed dismay that the Pepperwood Lot was being described as city-owned property. She said it was bought and paid for by the merchants in a private/public partnership with the city. If developed, it was to remain for retail use only. She felt all the merchants needed to see and approve any proposals for development. Ms. Atkinson further commented on the importance of available parking in retail areas.

Mayor Manross closed public testimony.

Mr. Roderique confirmed that the lot is owned by the city, although local merchants placed funds into an Improvement District that was used as the financing mechanism to purchase the property.

Councilman O'Hearn urged complete understanding of the economic feasibility of any conceptual plan that the city considers.

- Authorize \$721,111 (Option A) or \$891,911 (Option B) budget transfer from the FY 2003/04 Operating Contingency Budget (100-99501-57790) to the Police Department City Facility and Workplace Security Center (402-E0402-54901) for \$605,100 (Option A) or \$775,900 (Option B) and the Police Department Canine Services for \$116,011 to purchase security equipment, enhance building security through modifications, increase the number of security guards and hire one canine officer.
- Authorize the City Court to expend \$50,000 from the Court Enhancement Fund to purchase new x-ray screening equipment.

Marc Eisen identified the options for enhancing security at five city buildings. In Option A for City Hall, Mr. Eisen described the equipment and construction necessary for upgrades. Option B called for an additional guard, enclosing the front portico, and the addition of X-Ray Explosive Detection Equipment. Costs for Option A would include Capital costs of \$533,500 and annual Operating costs of \$249,600; Option B would include Capital costs of \$693,500 and annual Operating costs of \$350,000.

Mayor Manross opened public testimony.

Lyle Wurtz, 6510 E Palm Ln, 85257, expressed concern regarding access for disabled citizens, the possibility of being frisked, and more and more rights being taken away from private citizens.

Mayor Manross closed public testimony.

Mr. Eisen clarified that citizens would not be frisked, but would go through detection machines similar to those at airports.

Mayor Manross encouraged Council to consider Option B; otherwise she felt they would be looking at adding the detection machines in a year anyway.

MOTION – ITEM 29

COUNCILMAN LITTLEFIELD MOVED TO AUTHORIZE FUNDING (OPTION A) TO ENHANCE SECURITY AT CITY FACILITIES. COUNCILMAN SILVERMAN SECONDED THE MOTION, which carried 7/0.

Chief Rodbell, responding to Councilman O’Hearn, said he would recommend Option B now as the additional equipment would most likely be revisited at a later date.

30. Review of 2004-2005 Capital Improvement Projects Budget

Craig Clifford described the budget process and reviewed the proposed Capital Project Budget of \$741.1 million. He also discussed impacts of Capital projects on the Operating Budget. CIP Budget highlights were reviewed for Neighborhood and Community, Facilities, Drainage and Flood Control, Public Safety, Transportation, Technology, and Water and Sewer. Funding impacts to citizens included an average two percent increase in water/sewer fees, and a decrease in property tax from \$1.12 per \$100 assessed value to \$1.07.

Vice Mayor Ecton said he had carefully reviewed the Capital and Operating budgets as a member of the Budget Subcommittee and expressed concerns about some projects being pushed back too far. He requested that staff look for ways to include the Appaloosa Library, the expansion at the Arabian Library, and a Helicopter for the Police Department in the operating budget.

Ms. Dolan clarified that, although the Arabian Library is scheduled for construction in 2006/07, community meetings would actually begin this July. The design portion of the project would begin in January 2005.

Responding to Councilman Ortega, Mr. Clifford reviewed Capital Projects on the horizon for access into the preserve. Ms. Dolan noted some of these are part of the Bond 2000 Program.
