The Planning and Development Services Department has completed the review of the above referenced submittal dated 05/23/07. The following 1<sup>st</sup> Review Comments represent the review performed on the project by our team, and are intended to provide you with guidance for compliance with city codes, policies, and guidelines related to this application type.

## Ordinance Related Issues

The following ordinance related issues have been identified in this first review of the project and will need to be addressed in a re-submittal prior to scheduling a hearing.

## Zoning:

1. The proposed "Primary Signs" shown in the application do not meet Zoning Ordinance Requirements. Signs are not permitted to be placed on top of a shade canopy or to be located any higher than the front fascia of the canopy if mounted on the fascia on the front of the canopy. Revise the master sign plan to reflect this requirement.

Please resubmit the revised master sign plan and a written summary response addressing the comments/corrections identified above as soon as possible for further review (Please see Attachment A, Resubmittal Checklist, for a consolidated list of information to be resubmitted). The City will then review the revisions to determine if it is ready to be scheduled for a hearing date.
