



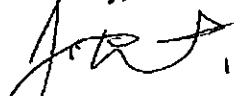

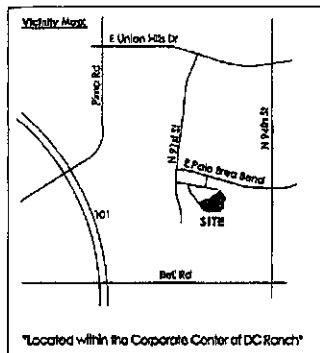
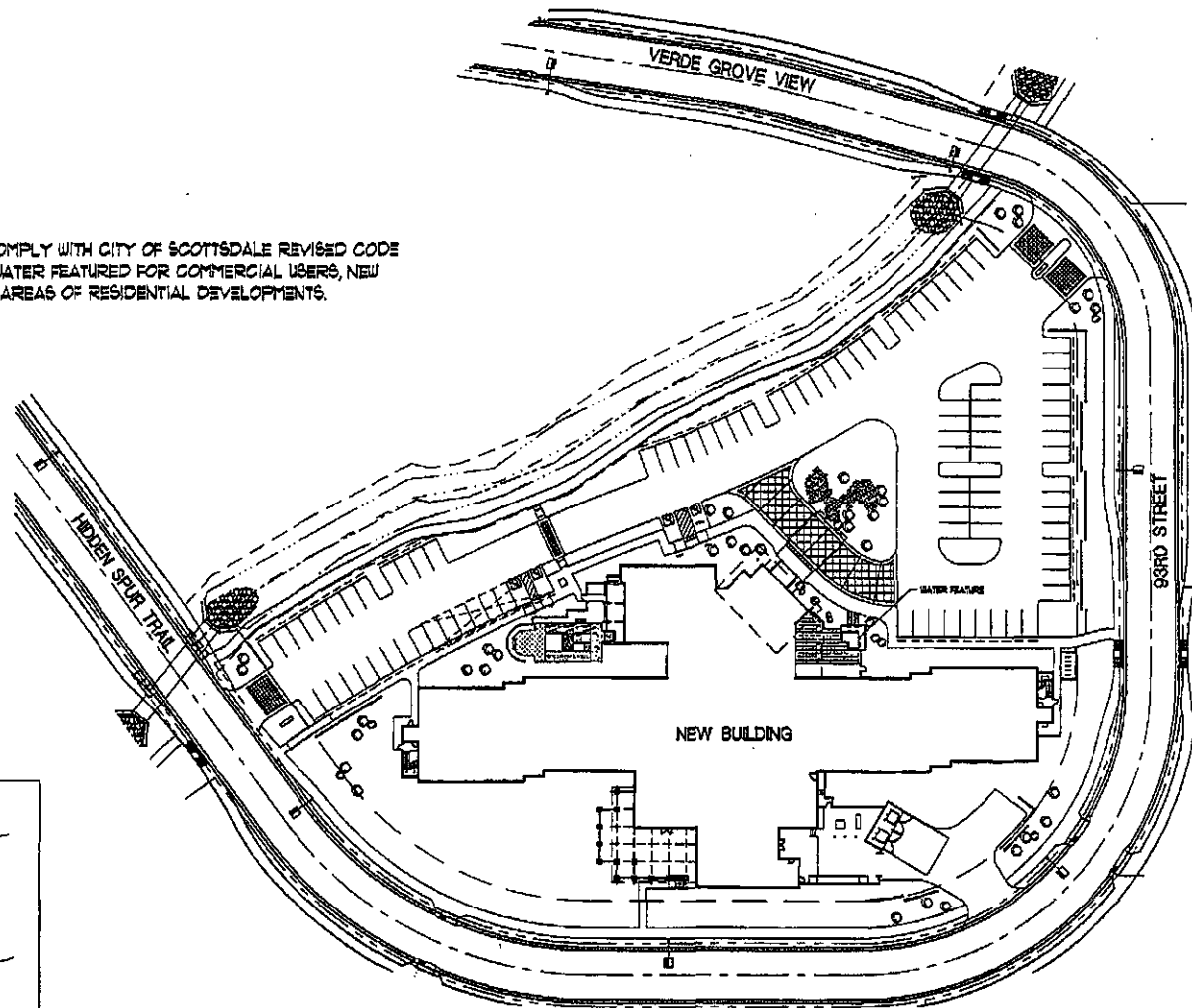

Site Plan

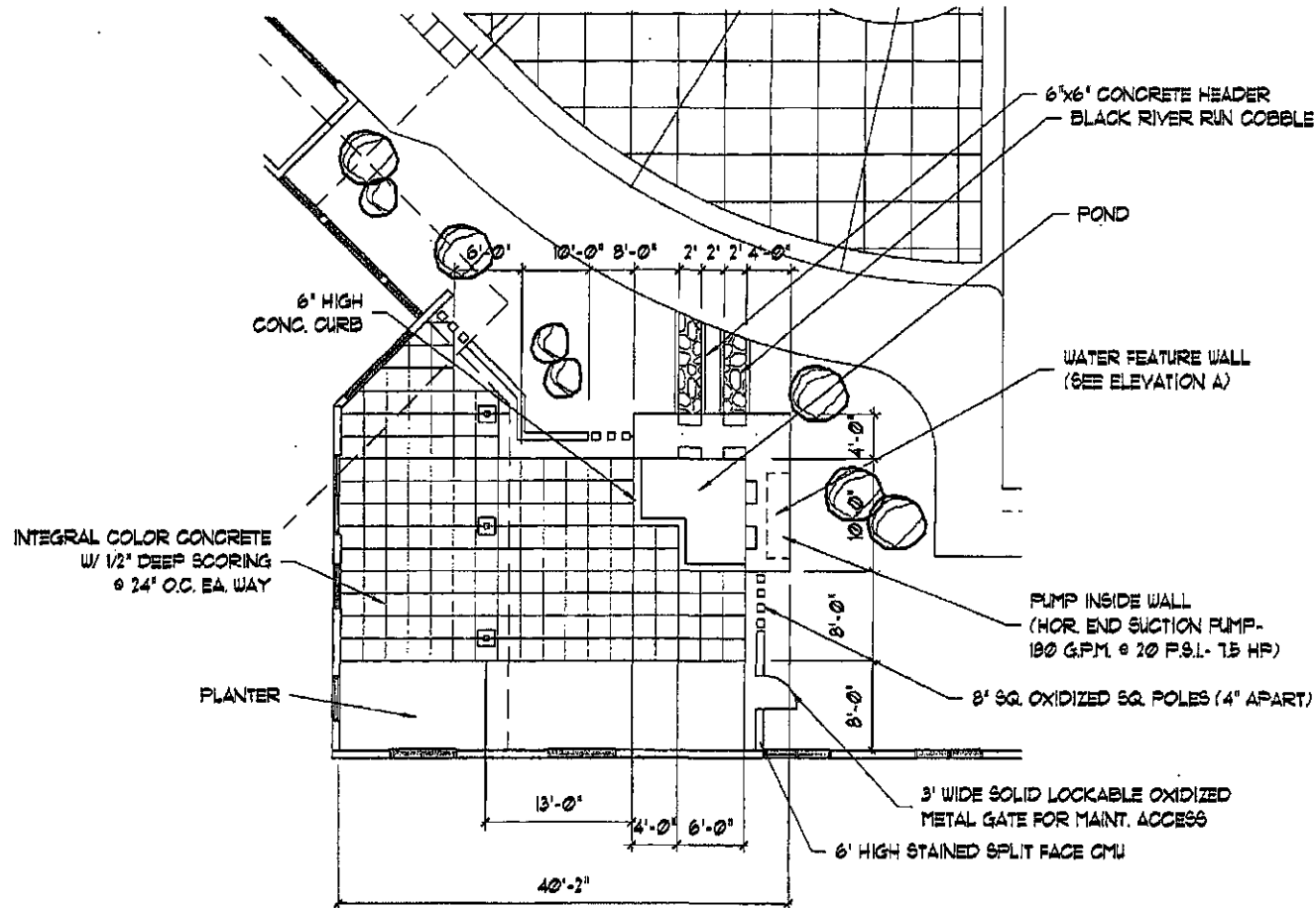

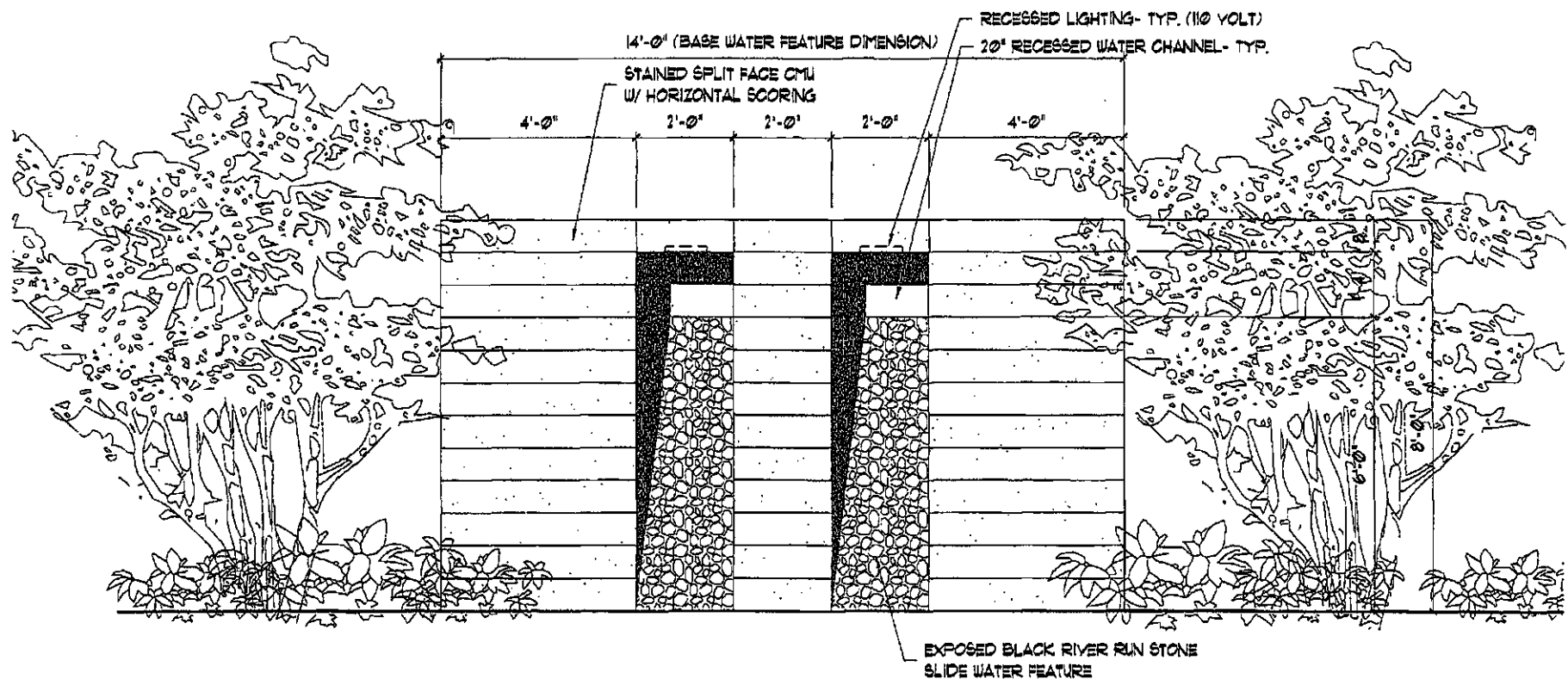
