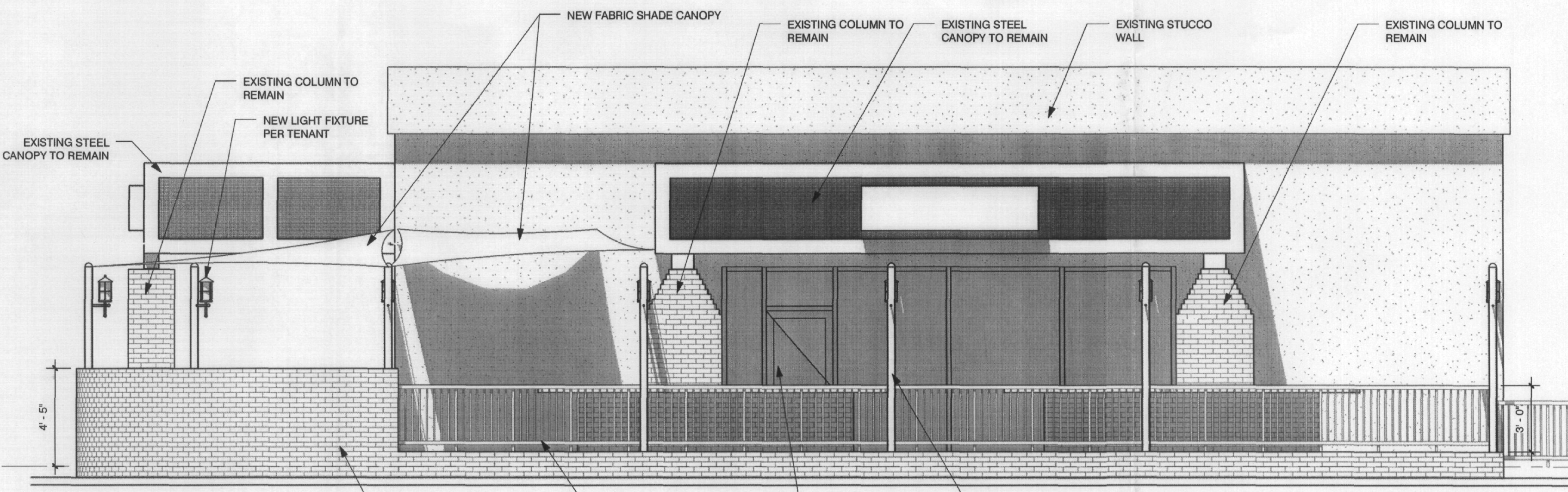
1 ENLARGED SITE PLAN/ FLOOR PLAN

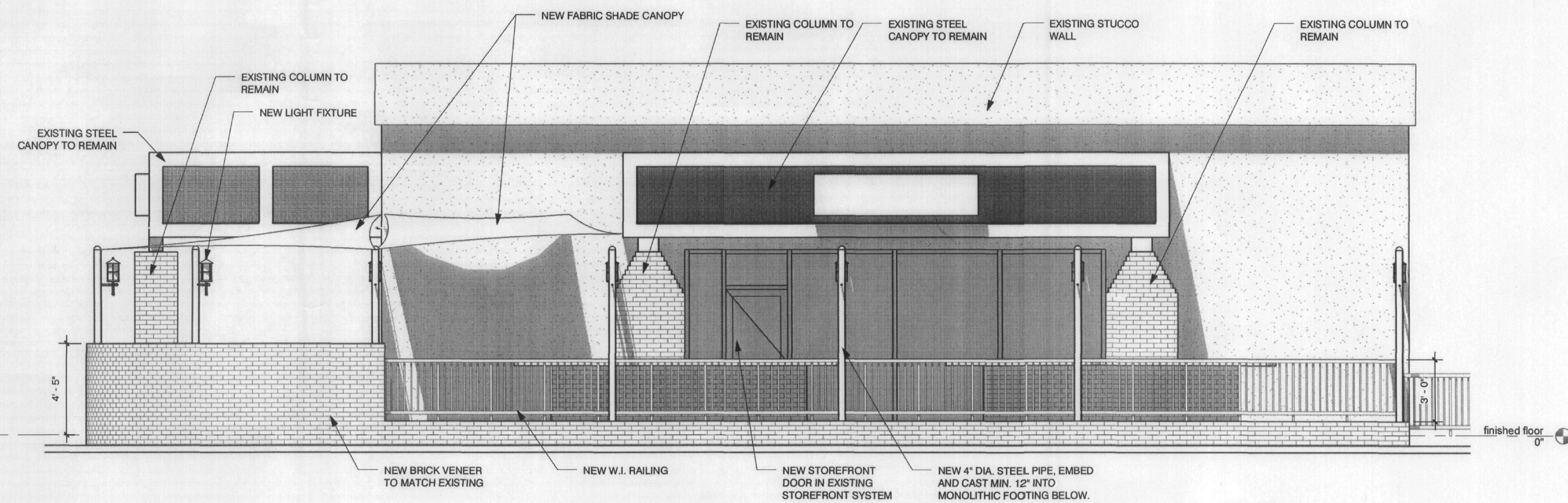
1 ENLARGED SITE PLAN/ FLOOR PLAN
