In regards to the wireless communication facility located at 9850 N. 73rd Street, Scottsdale AZ. 85258, AT&T wireless is requested to replace the existing antennas with new 4g antennas. The current configuration consists of three (3) antennas and these will be replaced with six (6) new antennas. The dimensions of the ground equipment compound will not be affected.

The existing wireless communication facility is located on an existing APS power pole south of Shea on the east side of Scottsdale Rd. The property is currently zoned R-5.

This development will not affect any vehicular or pedestrian patterns. The communication site does not emit any odor, dust, gas, noise, vibration, smoke, heat or glare. The RF emissions from this site are well within FCC guidelines for a digital PCS communication site.

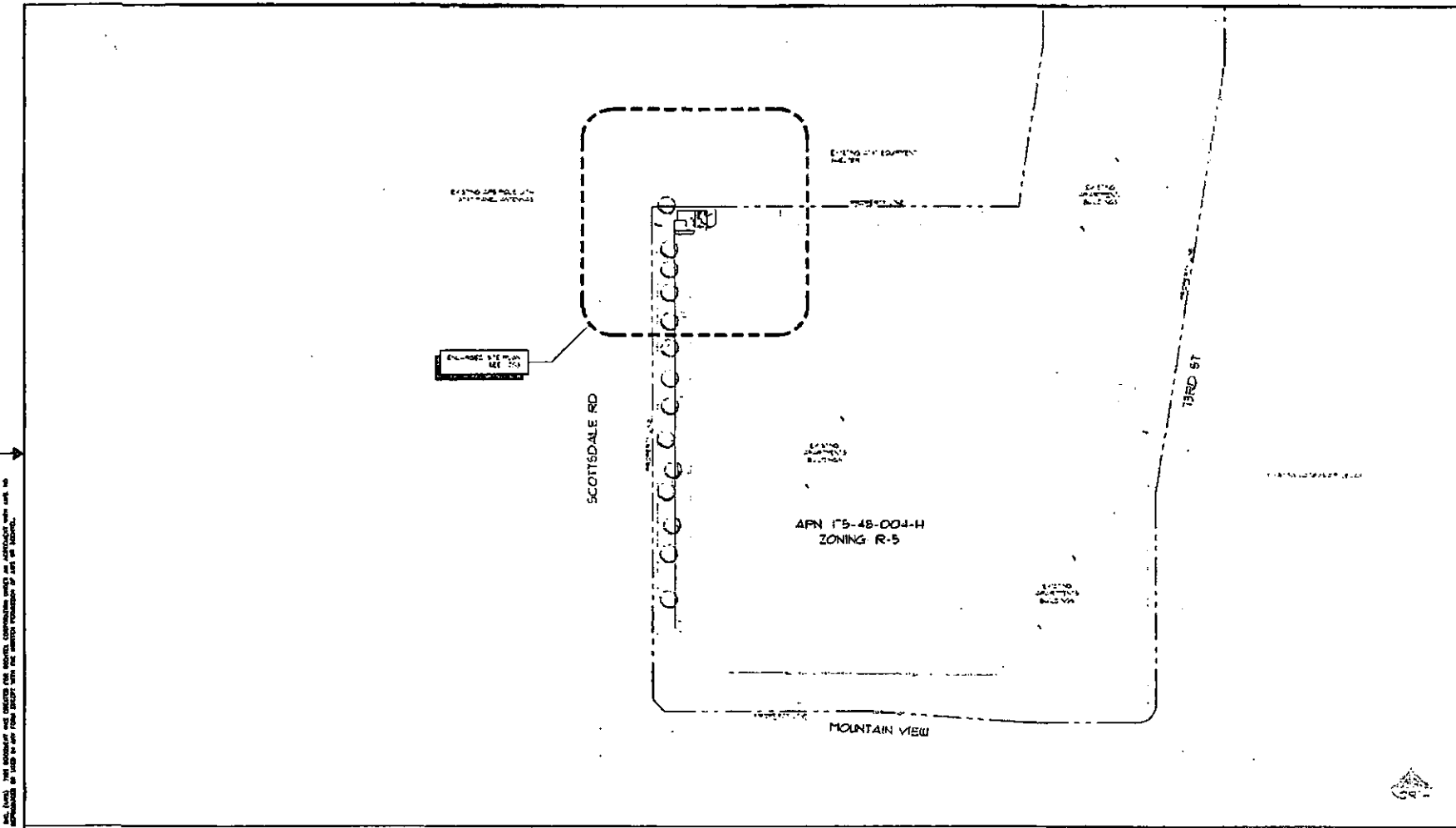

SITE PLAN

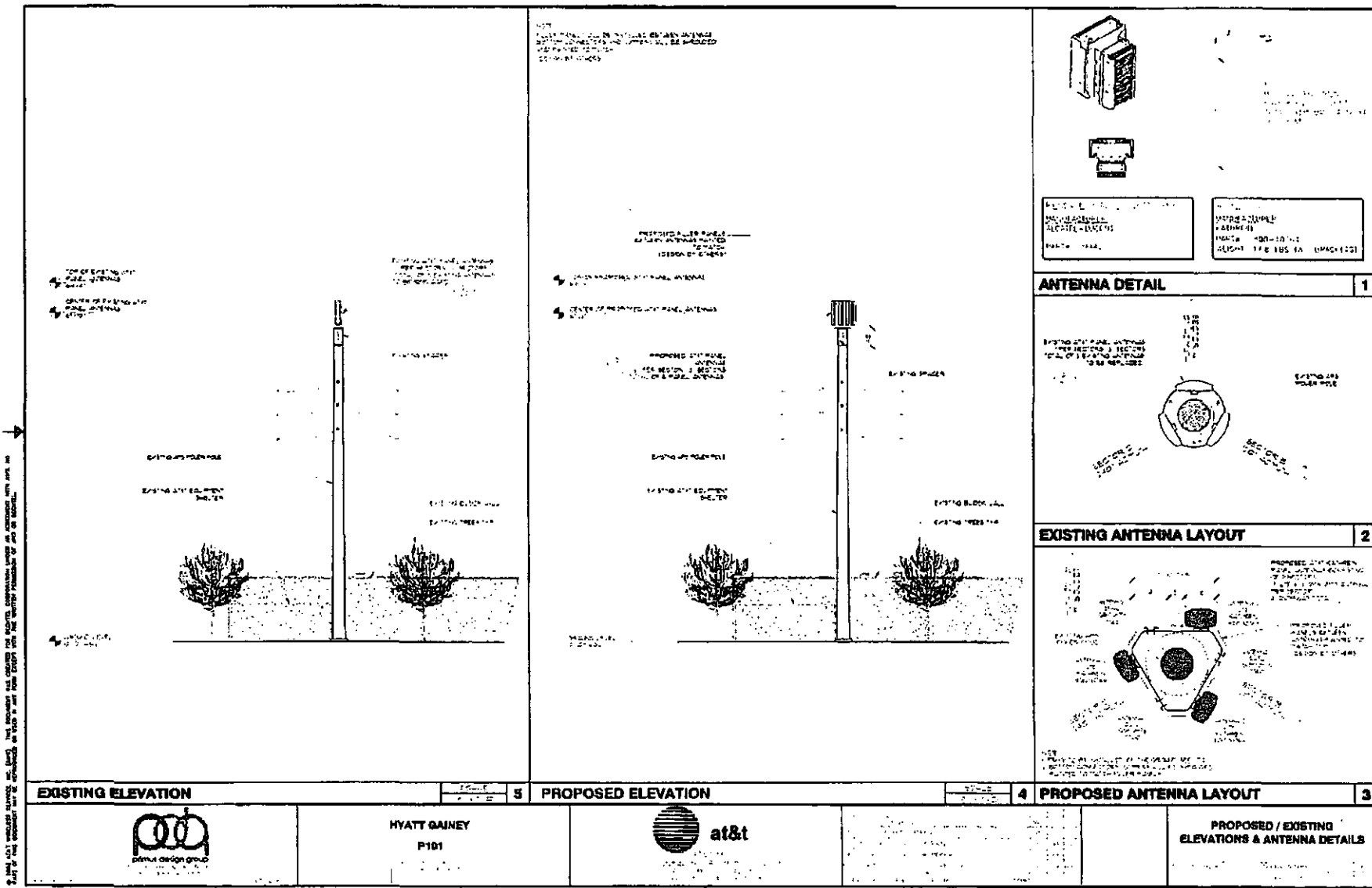
