

CITIZEN REVIEW REPORT
Scottsdale Waterfront Phase 4
October 8, 2010

Overview

This citizen review report is being prepared in association with applications for the continued development of the Scottsdale Waterfront with its fourth phase. The applications seek to amend the approved stipulations. The Scottsdale Waterfront Phase 4 will be a multi-use project on the currently vacant property located at the southeast corner of Goldwater Boulevard and Via Soleri Drive.

The entire project team is sensitive to the importance of neighborhood involvement with property owners, residents, business owners, homeowners associations, and other interested parties. Communication with these parties will be ongoing throughout the process. Work on compiling a stakeholders list and preparing for the neighborhood outreach began prior to the application filing and will continue throughout and after the process. Communication with impacted and interested parties may take place with verbal, written, electronic, and door-to-door contact.

Community Involvement

The Waterfront project team has been busy conducting outreach into the community to date. We have been doing many individual and small group meetings with residential neighbors to inform them about the proposed change and to gather their input. We have also met with representatives of the Waterfront Residential Association. We will be meeting with representatives of the Waterfront Residential Association again to further discuss the application and address their questions.

On September 24, 2010 a notice was sent via first class mail to property owners inviting them to a neighborhood open house on October 4, 2010. The notice (see attached letter) was mailed to property owners (see attached list and notice area map). The notice contained the time and location of the meeting, information regarding the project, and contact information for those unable to attend or those seeking more information. The neighborhood meeting was held on October 4, 2010 at The Chef's Loft, 7114 E. Stetson Drive.

The open house was attended by thirty-two (32) people (see attached sign in sheets) who were all interested in the project. The attendees were

appreciative of the outreach effort and the plans on display. Several of those at the meeting were in support of the project and some expressed concern about height on the eastern edge of the project. We will continue to be available to meet with any neighbors who wish to discuss the project. Additionally, we will be contactable via telephone to answer any questions relating to the project.

A vital part of the outreach process is to allow people to express their concerns and understand issues and attempt to address them in a professional and timely matter. As previously stated the entire team realizes the importance of the neighborhood involvement process and is committed to communication and outreach for the project.

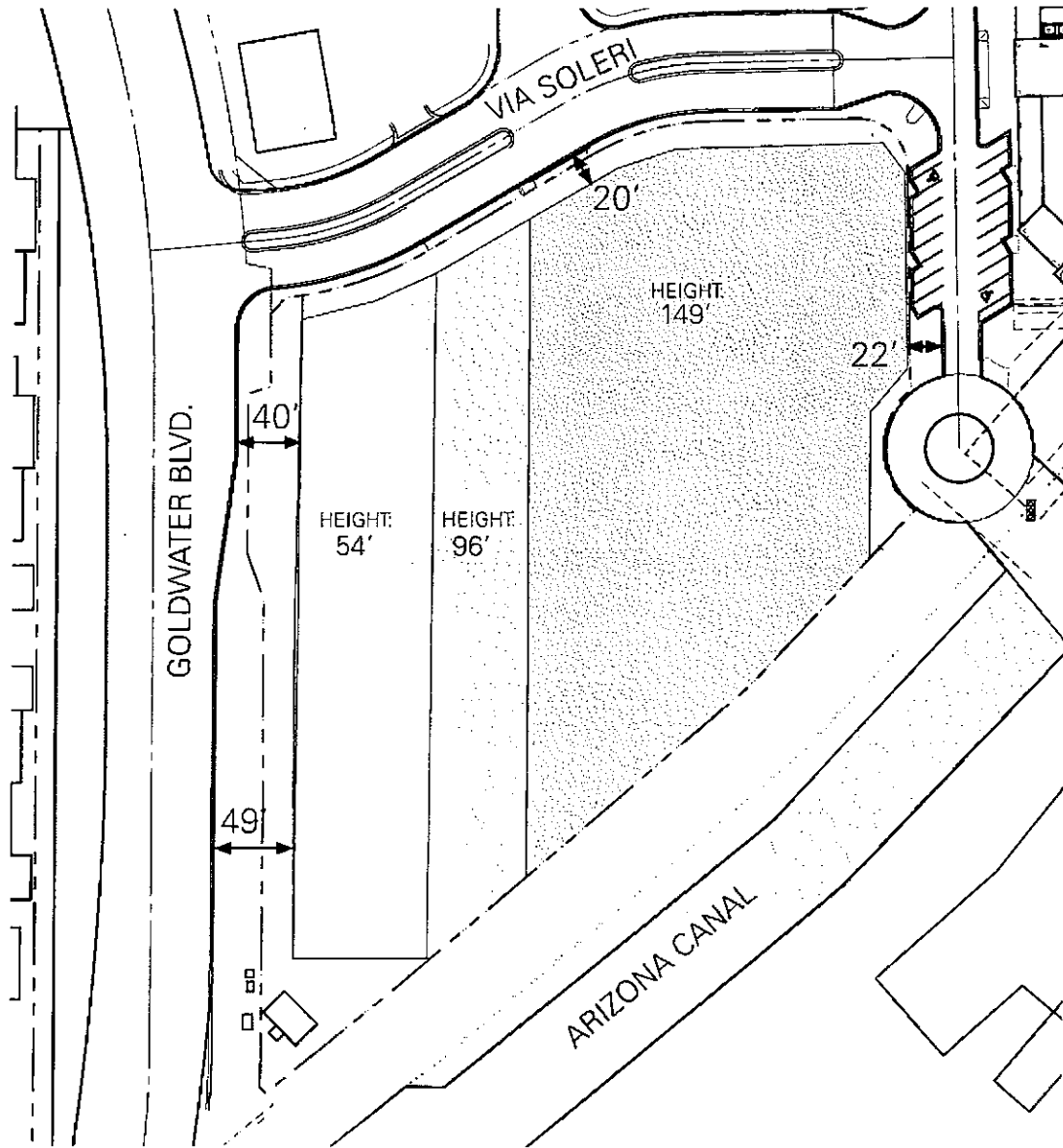

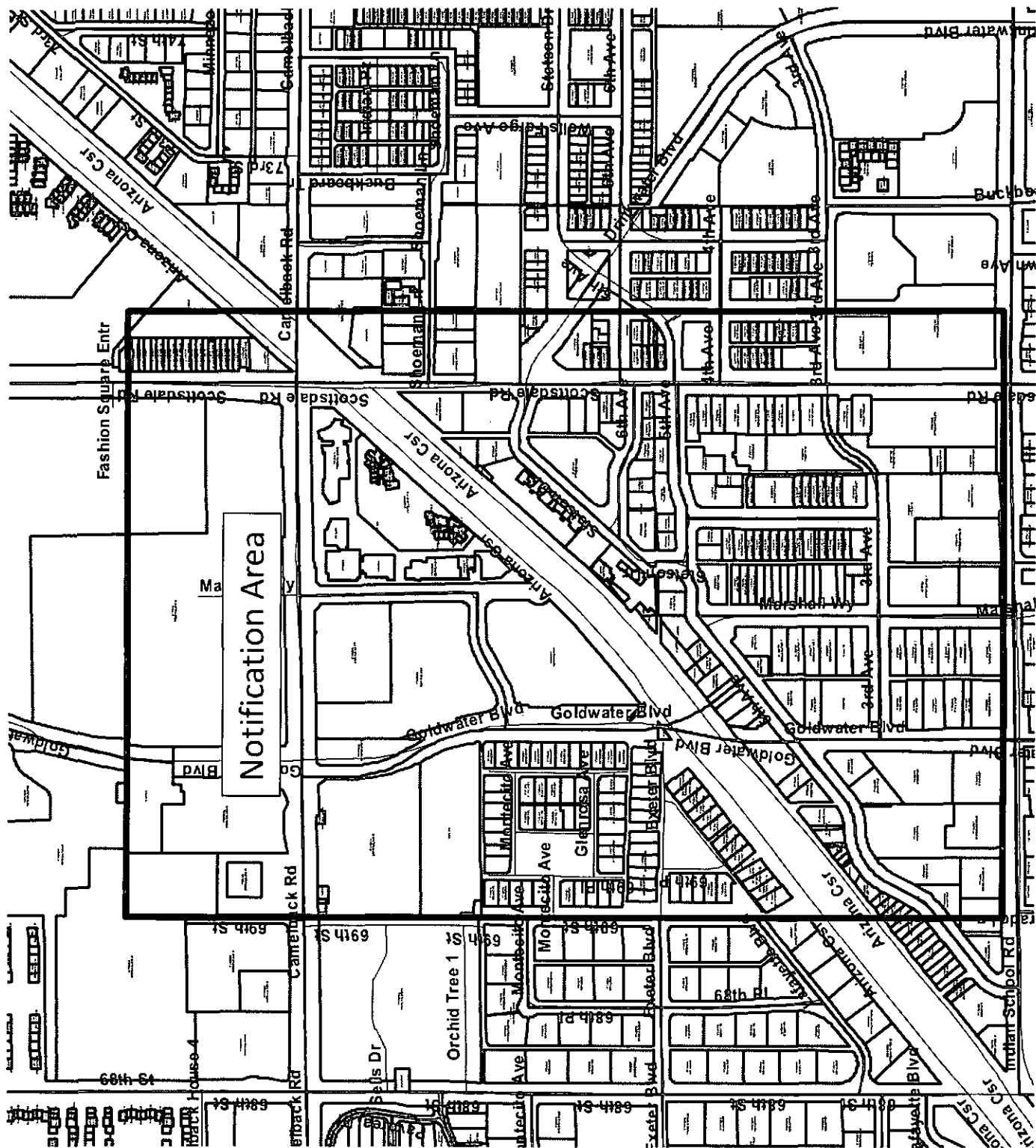
