Woman dies, 4 hurt in rollover

A woman was killed and four people injured Thursday when their truck rolled several times on a dirt road about 10 miles northeast of Cave Creek, a fire official said. Renae Walker, 18, of north Phoenix, was pronounced dead after the 1 p.m. crash on Horseshoe Dam Road, Maricopa County sheriff's Sgt. Paul Chagolla said. Two people in the truck were flown to Scottsdale Healthcare Osborn hospital with serious injuries. Two people with less serious injuries were driven to the same hospital, said Sandy Nygaard with the Rural/Metro Fire Department. The oldest was 24 years old, she said. Lisa Allen MacPherson, spokeswoman for the sheriff's office, said the truck had been travelling too fast on the dirt road.

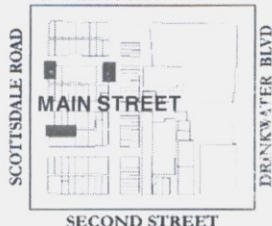

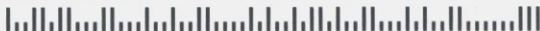

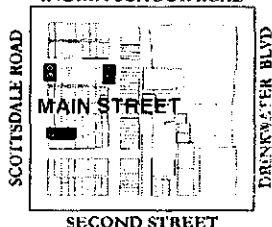

VICINITY MAP INDIAN SCHOOL ROAD



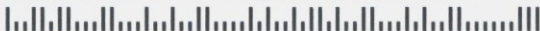

3 places worth protecting

Our stand: Local spots stir memories

What's so funny about giving official historic recognition to the Pink Pony, the Sugar Bowl and the Simonson Building?

Granted, they're not necessarily such great shakes as buildings, though that's a perennial complication when talking about historic preservation in Scottsdale, established 1951.

But the Pink Pony steakhouse and the Sugar Bowl ice cream parlor, at least, are great Scottsdale businesses. They're both mainstays that have survived the fickle public's changing tastes and trends. Ask any group of Scottsdale residents about what they like about downtown, and both the Pink Pony and the Sugar Bowl will come up, guaranteed.

The Pink Pony's historic pedigree is a bit peculiar. The restaurant — and legendary spring training baseball hangout — has been at its current address at 3831 N. Scottsdale Road only since 1970. Its original location was a bit farther north on the corner of Scottsdale and Main Street. The current one once had housed a general store.

Longtime Pink Pony proprietor Charlie Briley, an institution there from 1951 until his death on Dec. 17, 2002, was a big-time baseball booster, and his place hosted all the legendary Hall of Fame names, including Joltin' Joe DiMaggio, Ted Williams and Willie Mays, the "Say Hey Kid." All-time great baseball manager Billy Martin and singing cowboy and baseball owner Gene Autry also loved the Pink Pony.

The Sugar Bowl is to Scottsdale what the also-venerable Mary Coyle ice cream parlor is to Phoenix — a timeless shrine to sweet confections. It's just up the road a piece from the Pink Pony at 4005 N. Scottsdale Road. Readers of "The Family Circus" may recognize the 1958 vintage ice cream palace; cartoonist and Northeast Valley resident Bill Keane is a longtime patron and over the years has name-dropped the establishment in the popular newspaper strip.

The Simonson Building also is immediately

familiar to anybody who grew up here. It's at Brown Avenue and First Street in Old Town Scottsdale.

The Scottsdale Historic Preservation Commission is now exploring the possibility of adding the three buildings to the local historic register. Public hearings will be held early this year and ultimately the Scottsdale City Council will have to decide.

We don't know if the Pink Pony, the Sugar Bowl and the Simonson Building are historically significant according to some sort of dry, bureaucratic, textbook definition of the term. Frankly, we really don't care.

We know that those places are historic in the truest sense of the word. They have held steady throughout Scottsdale's march of time. They help define what downtown Scottsdale is and has been since the 1950s. They are much more relevant than a lot of obscure and arcane houses and structures that are revered by pop culture and architectural historians.

And they evoke a lot of fun memories.

For those reasons, if for no others, the Pink Pony, the Sugar Bowl and to a much lesser degree the Simonson Building should be recognized and hailed.

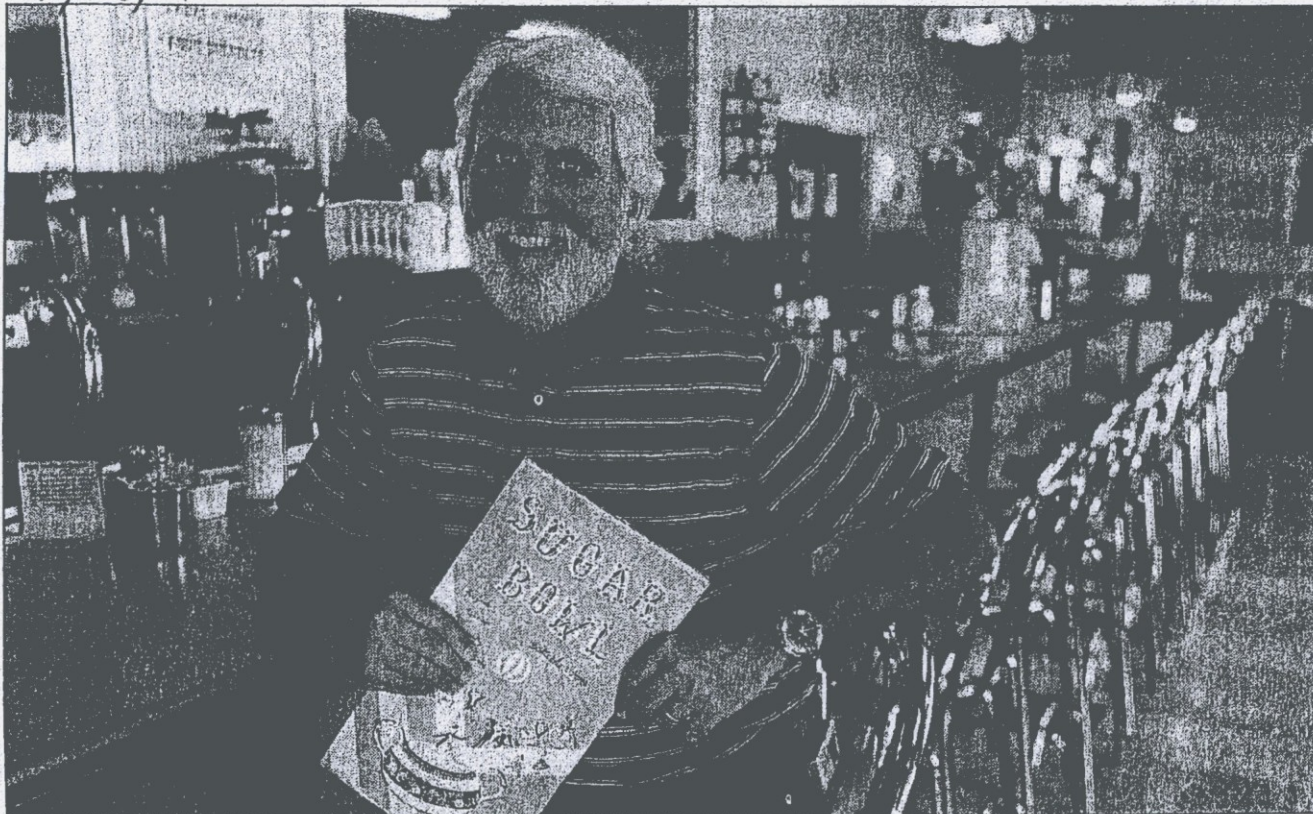

Scottsdale's sweet spot

Sugar Bowl, 2 other sites considered for city historic register

Scottsdale High School sophomore Kit Russell was nervous on his first date with fellow student Michele Prosnier — and wasn't sure if he should sit beside her on their date.

It was a hot July night in 1975. Russell took Prosnier for ice cream at the Sugar Bowl in Scottsdale after a drive-in movie.

Settling into a small two-seat booth in a corner of the eatery, Russell couldn't decide if he should sit beside his date, he said. Now married with three boys, "we still argue over whether I sat next to her or across from her," Russell said.

The Russells retell the story during family trips to the Sugar Bowl. The ice cream parlor hasn't changed much: It is still decorated in

pink, still resembles an old-fashioned ice cream parlor and cafe, and still serves the same classic ice cream concoctions as it did on its first menu — such as root beer floats and banana splits.

The Sugar Bowl is one of three buildings in downtown Scottsdale being considered for addition to the city's historic register, currently at 13 sites. The Historic Preservation Commission on Monday will hold its second of two open houses informing the public about adding the Sugar Bowl, along with the Pink Pony restaurant and the Simonson Building, to the list.

The Sugar Bowl's decor includes pink booths large enough for families to sink into, an old-fashioned bar with tall pink stools and an original cashier's window at the door.

Western Motor Service designed the building in 1950 in line with Scottsdale's Western atmosphere, according to information compiled by city historic preservation officer Debbie Abele and her staff.

Jack Huntress of Paradise Valley opened the Sugar Bowl in 1958 as a family-oriented alternative to restaurants that served alcohol. A retired Chrysler marketing and sales representative from Detroit, Huntress was active in his community and served 10 years as mayor of Paradise Valley, said Carroll Huntress, Jack's nephew and current Sugar Bowl owner. When Jack turned 70 in 1980, Carroll moved to Arizona to help run the business. In 1985, he bought it, with Jack Huntress' family retaining ownership of the building, Carroll said. Jack died in 1998.

Drawings from local commercial artist Pat Thompson and cartoonist Bill Keane hang throughout the restaurant. Thompson designed the Sugar Bowl's first menu cover, which is still used today. Keane, a longtime friend of the Huntress family and frequent customer, featured the Sugar Bowl in his "Family Circus" cartoons.

Three public meetings are to be held for consideration of adding the three buildings to the historic register. On Feb. 9, the issue goes before the Historic Preservation Commission, which will review the information compiled by Abele and her staff. Separately the Planning Commission will look at creating a zoning overlay with historic preservation status.

The City Council will then consider the case, taking into account recommendations of both commissions. The process should be completed by May, Abele said.
