

The undersigned, both individually, and on behalf of FACILITY USER and each member thereof, and in consideration of the fact that St. Maria Goretti Roman Catholic Church ("PARISH") has granted FACILITY USER's request to use certain property and/or facilities owned or managed by PARISH, hereby agrees as follows:

- 1. That FACILITY USER is not a part of the Diocese of Phoenix ("DIOCESE") or any parish in DIOCESE, is not affiliated with or sponsored by the DIOCESE or PARISH, is not an agent of DIOCESE or PARISH, and does not speak for or represent DIOCESE or PARISH.
- 2. That while DIOCESE or PARISH or their employees may provide spiritual support or spiritual direction to FACILITY USER or its members, any such spiritual support or direction is in matters of religion only and does not create any form of agency or master/servant relationship between FACILITY USER, on the one hand, and DIOCESE or PARISH, on the other.
- 3. That FACILITY USER is not controlled by DIOCESE or PARISH or any employee or agent thereof, and that neither DIOCESE nor PARISH will receive a direct, tangible or financial benefit from the FACILITY USER's activities, other than the consideration given or rental fee paid by FACILITY USER for the use of the facilities, as set forth in Attachment "A" hereto.
- 4. That FACILITY USER is not a participant in and is not the beneficiary of any financial protection provided by the Catholic Mutual Protected Self-Insurance program or by any insurance coverage paid for or carried by DIOCESE or PARISH, and further that FACILITY USER understands that it will not be indemnified by DIOCESE or PARISH for any liability arising from FACILITY USER's activities.
- 5. That any and all liability, whether civil, criminal or otherwise, and whether arising from use of motor vehicles or arising from any other activity of the FACILITY USER or its members, is not assumed and is expressly rejected by the DIOCESE, PARISH and Catholic Mutual.
- 6. That FACILITY USER agrees to fully protect, defend, indemnify and hold DIOCESE, PARISH, Catholic Mutual and their employees and agents harmless from and against

any and all liability sustained as a result of activities of the FACILITY USER, its members, or other facility users or members acting on behalf of FACILITY USER.

- 7. That FACILITY USER understands that neither DIOCESE nor PARISH, nor Catholic Mutual waive any right they may have to seek indemnity from any individual member of the FACILITY USER if that member's actions lead to a lawsuit or claim or other proceeding against DIOCESE, PARISH, or Catholic Mutual.
- That this Agreement confers no right to use DIOCESE or PARISH property other than the limited and specific use specified above.



- 10. That if this Facility Use Agreement is being used for the rental of St. Maria Goretti property, that FACILITY USER will abide by the Terms of Use attached as Attachment "B" hereto. In addition, the following rules shall apply:
 - The Grounds may only be used between the hours of 12:00 p.m. and 10:00 10 p.m.;
 - b. All activities and music on the Grounds must cease by 10:00 p.m.
 - c. Decorating the Grounds in advance is advised. Decorations can be put up on the morning of the event, schedule permitting. Removal of all decorations is the responsibility of the FACILITY USER and any decorations left on the Grounds will result in a fine and the withholding of the security deposit. NO STAPLES, NAILS, PUSII PINS OR HOLES OF ANY KIND ALLOWED IN WALLS. The only tape allowed is blue painter's tape so as not to remove the paint.
 - e. A facility pre-inspection and walk-through must be conducted by FACILTY USER with PARISH personnel ______, who can be reached at ______ (cell) or ______ (home).
 - f. Clean up of the Grounds must be completed at the end of the event. Failure to do so will result in forfeiting of damage deposit
 - g. FACILITY USER understands and agrees that the GROUNDS OR Hall may not be used for any political campaigns
 - There shall be no smoking at any time on the Grounds or on PARISH premises.
- 11. That FACILTY USER must pay a security deposit of \$250.00 which is intended to cover damage to PARISH buildings or property beyond reasonable wear and tear.
- 12. That FACILITY USER must designate a person responsible for any event or use to be conducted by FACILITY USER. The responsible person must be an adult over the age of 21, must be present for the duration of the event or function and shall be responsible for maintaining all rules and policies provided herein.

- 13. That FACILITY USER shall at all times comply with all applicable federal, state, city or county ordinances, codes or laws, including the applicable fire and safety codes and ordinances; that children shall not be allowed to run free throughout the PARISH buildings or property; that any use of rollerblades, roller skates, or skateboards on or inside the PARISH facilities and the PARISH grounds is prohibited; that any food items or beverages served in connection with the proposed use, and any refuse resulting from such use, including refuse on church grounds and parking lots, must be properly disposed of by FACILTY USER at the end of the event; and that any spills on PARISH property are to be cleaned up immediately. All refuse must be bagged, tied, and thrown in the dumpster. All restrooms must be kept clean, tidy, and free of garbage.
- 14. That FACILITY USER shall be responsible for any damage caused to PARISH property by any employees, agents, partners, family members, students, customers, function attendees, guests, invitees, organizational members or associates of FACILITY USER, and shall reimburse PARISH and/or DIOCESE for the cost to repair said damage within five (5) days of presentation of a receipt for said repair costs. FACILITY USER shall also be responsible for the cost of any stolen property.
- 15. That FACILITY USER, contemporaneously with the signing of this Facility Usc Agreement, shall (1) sign an Indomnity Agreement in favor of DIOCESE and PARISH, (2) provide a certificate of insurance to PARISH, which shall provide evidence of general liability coverage of not less than two million dollars (\$2,000,000.00) per occurrence, effective on the date(s) of proposed use, and (3) name PARISH and DIOCESE as "Additional Insureds" on its general liability policy for the DATE(S) OF FACILITY USAGE for any claims which arise out of FACILITY USER'S operations or for any claims that may be brought against PARISH OR DIOCESE by any employees, agents, partners, family members, students, customers, function attendecs, guests, invitees, organizational members or associates of FACILITY USER.
- 16. That the authorization or permission to use DIOCESE or PARISH property may be terminated at any time and shall be deemed terminated at the time that FACILITY USER's use of the property discontinues; however, the representations, warranties and indemnity obligations contained herein shall survive termination of this Agreement.
- 17. That the undersigned representative of FACILITY USER has authority to execute this Agreement and represents and warrants that it has advised every member of the FACILITY USER of its contents.
- 18. That this Agreement may not be assigned by FACILITY USER to any other person or party without the express written consent of PARISH.






