#### THIRD AMENDMENT TO MASTER WASTE MANAGEMENT SERVICES AGREEMENT

This Third Amendment to Master Waste Management Services Agreement (this "Amendment") is entered into as of  $\mu a \eta \parallel$ , 2018 by and between The Macerich Partnership, L.P., a Delaware limited partnership ("Macerich"), and Keter Environmental Services, Inc., a Delaware corporation ("Keter"), based on the following facts and circumstances:

- A. WHEREAS, Macerich and Keter have entered into that certain Master Waste Management Services Agreement dated June 1, 2014, as amended by that certain First Amendment to Master Waste Management Services Agreement dated October 2, 2015, as further amended by that certain Second Amendment to Master Waste Management Services Agreement dated March 2, 2018 (as amended, the "Agreement"), pursuant to which Keter provides total waste management services, including managing waste collection, transportation, disposal and recycling services, for the Centers (as defined in the Agreement), all as more particularly described in the Agreement; and,
- **B.** WHEREAS, Macerich and Keter desire to enter into this Amendment to reflect certain agreed upon changes to the Agreement as provided for herein.

NOW, THEREFORE, the parties hereby agree as follows:

- 1. Defined Terms. Unless otherwise specifically provided in this Amendment, all terms that are defined in the Agreement shall have the same respective meanings when used in this Amendment as given to said defined terms in the Agreement.
- 2. Add Arizona Properties.
  - a. Exhibit A, Operating Costs. Effective May 1, 2018, Exhibit A to the Agreement shall be deleted in its entirety and replaced with Exhibit A attached hereto and incorporated herein by reference so as to add the following Centers and their respective operational costs to the Agreement: (i) Arrowhead Towne Center, (ii) Biltmore Fashion Park, (iii) Chandler Fashion Center, (iv) Desert Sky Mall, (v) Paradise Valley Mall, (vi) SanTan Village Regional Center, (vii) Scottsdale Fashion Square, (viii) Superstition Springs Center, (ix) Estrella Falls, (x) Kierland Commons, (xi) La Encantada, (xii) Promenade at Casa Grande, (xiii) Superstition Springs Power Center, and (xiv) Boulevard Shops (collectively, the "New Centers").
  - b. Exhibit K, Center Information. Effective May 1, 2018, Exhibit K to the Agreement shall be deleted in its entirety and replaced with Exhibit K attached hereto and incorporated herein by reference so as to add the the New Centers to the Agreement

- 3. Management Fee. Effective May 1, 2018 Exhibit A-1 to the Agreement shall be deleted and replaced with Exhibit A-1, attached hereto, and incorporated herein by this reference, so as to provide for the management fees as contemplated in Section 4.C ("managing the waste stream and the Merchant Billings for providing such services") and the second paragraph of Section 4.J, for the New Centers.
- Entire Amendment. Except as herein modified, the Agreement shall remain in full force and effect and nothing in this Amendment shall be deemed to waive or modify any of the provisions of the Agreement.
