Re: 22-DR-2017#2 We are writing on behalf of Old Town Townhomes, LLC, with respect to the proposed Waterview development project at Camelback and 73rd St. Old Town Townhomes, LLC, owns the 8 unit residential condominium adjacent to the Project, located at 7301 E. Minnezona. We have several serious concerns with the Project as currently proposed. We'd like to note that we support and welcome the Project in general and a realignment of 73rd Street. We strongly object, however, to the manner in which it is configured to unfairly impact the existing Old Town residences and property rights. We will briefly summarize the objections: 1) The proposed design and realignment negatively and drastically impact the current character and usage of the Old Town Townhomes. The front door of the Townhomes building, utilized by all unit residents, opens onto 73rd St. We have a 10-foot easement for access and landscaping which extends westward toward 73rd St. The proposed design apparently contemplates placement of the physical plant for the hotel immediately outside the front door, sandwiched between the Townhomes and the newly aligned 73rd St. The structures to be placed in that area are essentially what you would typically find in an industrial area, including a large emergency power generates
