

COMMENT

Members of the DRB - My wife and I live in Optima Camelview Village directly opposite the proposed hotel development at the corner of Highland and Goldwater. While we are supportive of the proposed development, we do have serious concerns about the effectiveness of the proposed 4 foot height of the glass in controlling noise from the pool and terrace area. Towards that end, we would ask that you raise the requirement for the glass barrier to at least 8 or preferably 10 feet in height. During events at the existing parking lot, such as the recent tennis tournament, the annual automobile auction, etc., noise generated by those activities has been problematic. In addition, on occasion, noise from pool and outdoor activities at the W Hotel on Camelback Road, has impacted our community. If I am not mistaken, the height of that glass barrier is 4 or 5 feet. As a retired landscape architect whose practice involved site design, it has been my experience that taller masses are most effective in deflecting noise upward and away from adjacent areas. A perfect example of this is where the high barrier walls adjacent to the Loop 101 between Shea and Via Linda shield the adjacent Pima Path and neighborhoods from the high traffic noise of the expressway. Dear Members of the Scottsdale City Council and the Development Review Board,

My name is Debra Stein, and I am a resident of Optima Camelview Village.

I am writing as a concerned neighbor regarding the design and the known subsequent noise which jeopardizes my community's quiet enjoyment based on the proposed design elements of the Caesar's Hotel.

The hotel's latest plan has inadequate noise reduction elements and I am concerned that the elements are insufficient to protect our community from consistent noise emanating from the outdoor pool, and from the open meeting space on the

lawn of the hotel.

Regarding the pool: the pool walls are not high enough nor is the proposed sound monitoring system sufficient to shield us from noise from the pool area.

The monitoring system only monitors the music level and will do nothing about curtailing the noise from hotel guests who will need to speak at volumes higher than the level of sound in order to have conversation.

It is a known fact that voices carry and we all know about the ongoing problems from noise from the music playing at the W Hotel, and from patrons of the bars and restaurant's in the entertainment district. This is what is bound to happen from a party deck pool. The hotel can say it is not so, and that the

hotel and the outdoor pool is not going to be a party atmosphere, however, the brand, Caesar's stands for a Las Vegas destination for fun and for entertainment. The brand Caesars does not personify quiet or reserved.

Although I appreciate the offer from the hotel to give our residents a direct line to call the hotel manager if the noise is bothersome, the offer itself lends credence that noise is going to be a problem for our community. I foresee a constant back and forth between multiple homeowners and hotel

management; all of which is less than a good use of anyone's time, when we can stop this problem from occurring now.

There is a great burden in which the Development Review Board and the City Council face when you vote to approve the hotel's proposed development plan, or not.

Can all members insure that the level of noise from the hotel's design elements will not impede on the quiet enjoyment of our residents and of the surrounding residential neighborhood?

I understood that Macerich was going to expand the mall when I purchased my home. However, a Las Vegas branded hotel, with an open pool with music, directly across the street from our community is not what the mall offers, which is shopping and upscale restaurants.

The fact that noise from the hotel's pool is being discussed is worrisome for my community and should be worrisome to all of you.

This hotel will change the nature of what is a now beautiful, quiet and upscale community.

I worry that our beautiful properties will lose property value once there is constant noise from the hotel. You should too.

I hope that the Development Review Board and City Council Members understand that noise from the proposed design of the Caesar's hotel will forever change my community and the surrounding neighborhood. As I see it, the current proposal before the Development Review Board and the City

Council will be a vote on whether the city approves the expansion of the entertainment district, which has and continues to be south and east of Camelback and is the source of constant problems between the residents of that neighborhood as a result of noise from the entertainment district's

establishments and their patrons.

The noise from the Caesar hotel's open pool and meeting space on the lawn will become a nuisance and will destroy the quiet enjoyment in which we live.

A vote to approve these design elements will be a vote to turn your backs on Optima Camelview Village and what collectively has been a half a billion dollar investment in the City of Scottsdale.

The Design Review Board and the City Council can vote to press pause and work with all parties to rethink what this hotel, which Caesar has said in their own press materials is a hotel in the spirit of Las Vegas, which is grossly inconsistent with my quiet and upscale residential neighborhood.

We live one block north of Optima. One of the attractions to this area was that it was walking distance to the mall and Old Town WITHOUT all the noise. It is the best of both worlds. Preserving neighborhoods like this should be the priority of this city.

Optima has been a wonderful neighbor in that it welcomes people to share their walkways and restaurant and yet they remain a very quiet, peaceful community. Clearly this atmosphere is important to those residents as well as ours.

When Days Inn changed hands to Hotel Adeline on Scottsdale Road, the obnoxious noise from their pool parties became a constant source of annoyance to our neighborhood. The city seems to be very happy to look the other way when the decibel level is so loud that houses literally vibrate from their pool parties.

I have little confidence that the Caesar will care about neighboring communities either. Their reputation precedes them. It would be comforting if residents of this city could actually depend on their mayor and city council to protect their very homes and neighborhoods from public disturbances. As you made have heard, plans to build a Caesar Republic Hotel across Highland Avenue from Optima have been announced. The design plans for the hotel have just been submitted to the City of Scottsdale. You can review the plans by pasting the following link onto your browser:

Alternatively, you can go to the City of Scottsdale web page www.scottsdaleaz.gov and type 30-DR-2019 into the search space. Click on Boutique Hotel.

The use as a hotel and the height of 150' have already been approved. Nothing can be done about those issues. However, we are able to impact the design of the hotel. The developer's plans call for a pool, restaurant and bar on the 7th floor facing northwest towards Camelback Mountain. These facilities will be only a few feet from Optima units along Highland Road. Caesar's has a world-famous reputation for its loud pool parties in Las Vegas. We don't want that repeated next to us.

The design of the hotel has to be approved by the City of Scottsdale. Now is the time to let the City staff, Mayor and Councilmembers and the Design Review Board know about your concerns.

The point person at the City is Bryan Cluff. Your comments should be emailed to him at heluff@ScottsdaleA7 gov. It would also be a good idea to copy the Mayor, city council members.

Please let the City know about your concerns. It is best to send messages using your own words. If appropriate, you could make the following points:

- 1. No amplified music or voices in the pool area.
- 2. No bright lights that would shine away from the hotel.

- 3. The glass wall around the pool should be at least 6 feet high.
- 4. The location of the pool should be moved to face south towards the sun and the parking garage. It should not face towards Optima.

Hello Mr. Layman,

Thank you for taking the time to comment on the submitted Development Review Board case for Caesar's Hotel. Your comments will be made a part of the record and included in our reports to the DRB. I would like to try and clarify/answer some of the requested stipulations you identify below.

There is currently no vehicular access from Goldwater to Highland at this location, and there is no plan for additional access. This issued was vetted during the zoning case review (25-ZN-2015) for the Fashion Square master plan, which also included a stipulation for fence improvements similar to your statement in #2 below. These improvements have already been completed to the extent possible, given the number and size of utilities that run through the street in this area. Since these are public streets, the City cannot provide gated access that would restrict pedestrian circulation.

As part of the staff review of the application we will be specifically looking at the potential reflectivity of the glass of the building to make sure there is not excessive glare onto adjacent properties, including the homes in your neighborhood.

Regarding Item #4 below, the below stipulation was included in the zoning approval for SFS and is applicable to the proposed hotel development:

"AMPLIFIED MUSIC. Within the area of the site identified as Parcel B on Exhibit A to Exhibit 1, there shall be no exterior amplified music after 10:00pm, and 11:00pm on weekends and holidays, at levels greater than 68 decibels as measured from the right-of-way line on the north side of Highland Avenue."




