At this time, due to the nature of the new development with it being similar to the existing structure/business type the developer shall submit the information below to Water Resources during the case review process. Basis of Design reports for water and sewer <u>will not be required</u>.

## WATER

-Utility plan showing all relevant services /Sewer lines/water lines/connections/meters... etc -Fire Flow determination per IFC and IBC (flow required from hydrant, not fire sprinklers) -Hydrant flow test to determine system pressures and adequacy for fire flow demands

## WASTEWATER

-Utility plan showing all relevant services /Sewer lines/water lines/connections/meters/grease trap... etc -Verify existing lateral location/Size to determine if upsizing is required. A 6" minimum sewer service lateral per MAG 440-3 s required for commercial properties.
