Purpose: The purpose of this Final Report for the Public Participation Plan is to relate to the City of Scottsdale the communications between the Developer and Design Team to the citizens and property owners in the vicinity of the site of an application for the new Kerry's Car Care facility (485-PA-2019). This site is located at the northeast corner of 116th Street and Shea Boulevard and is an application for a new car repair facility on a site currently unoccupied. The address for the site is 11653 E. Saguaro Drive.

This plan demonstrates that those affected by this application will have an adequate opportunity to learn about and comment on the proposal. The Developer of this Kerry's Car Care Facility voluntarily has decided to hold a neighborhood meeting in the council district of the project at a site to be determined. The meeting will be held on a weekday at 6:00 in the evening. Property owners and Home Owners' Associations within 750' of the subject property will be informed of the meetings by first class mail sent a minimum of 15 days prior to the meeting. The mails will include the project narrative and site plan. The neighborhood meeting will occur a minimum of 15 days prior to the hearing date.

This site is located at the northeast corner of 116th Street and Shea Boulevard and is an application for a new car repair facility on a site currently unoccupied. The address for the site is 11653 E. Saguaro Drive.

This plan demonstrates that those affected by this application will have an adequate opportunity to learn about and comment on the proposal. The Developer of this Kerry's Car Care Facility voluntarily has decided to hold a neighborhood meeting at their offices. The meeting was held on Monday 23 October 2019 at 5:00 in the evening. Property owners and Home Owners' Associations within 750' of the subject property were informed of the meeting by first class mail sent on 13 September 2019. The mails will include the project narrative and site plan. The neighborhood meeting took place a minimum of 15 days prior to the hearing date.

Neighborhood Meeting Presentations:

The meeting started with a brief presentation about Kerry's Car Care as a locally owned and operated company. The architect will then gave a brief walk through of the project design for site plan layout, site security and exterior elevation design.

The Development and Design Team explained the criteria of allowing a vehicular repair facility on a property in the C-3 Zoning District. The team explained how the site plan and operations of the business work to achieve the criteria. The meeting then be opened to questions from the audience.

Notification:

In addition to the mailings, the neighborhood meeting was announced via sign posted on the property on 11 September 2019 in accordance with the City of Scottsdale requirements. A copy of the Affidavit of Posting and picture of the sign are included in the application documents.

Results:

E-mails were received from John Gallagher, Amy McKee and Estelle Bloom. Their concerns are included in the outline list below. The emails are attached to this report. Five neighbors / interested individuals attended the Public Participation Open House.

At the neighborhood meeting, several of the participants objected to the current zoning of the subject property. They were informed to change the existing zoning of the project a process would need to be started by the land owner and taken in front of the Mayor and City Council for approval of the new district. The developer has no plans to re-zone the property and believes it is properly zoned at this time.

One neighbor objected to allowing the Use based on leaving a portion of the site designated as a future development. This neighbor did not object to Kerry's Use itself, but rather the potential future use on the existing to remain portion of the lot.

The neighbors claimed the installation of a business on the property would lower their home values. They did not provide any studies supporting this claim at the meeting. One of the purposes of zoning is to protect land values by providing appropriate adjacent uses. Certainly, an occupied, legally operated business is will stabilize or improve the value of adjacent properties more than a vacant lot.

Neighbors expressed concern about potential future tenants of the building. Kerry himself runs these businesses. His son-in-law is a location manager and is interested in taking over the business when Kerry retires, sometime in the distant future. Kerry is slowing expanding his business in the Phoenix area to allow his customers to have easy access to his shop should they move around the valley. There are no plans in place to sell this location to another operator and the business plan is not based on a real estate sale in the future.

Neighbors objected to the storage of parts, non-operational vehicles, etc. outside the building. However, no parts or discarded items will be stored outside of the building or trash enclosure. Kerry does not store anything outside at his existing locations, so they know how to properly operate while keeping their materials inside the building.

Neighbors objected to the trash dumpster. The trash dumpster will be inside a solid walled enclosure per the City of Scottsdale's requirements. The enclosure is proposed along the "back alley" drive at the north side of the property. This is the same trash collection area as currently used by the building housing Mountain Side Fitness.

Neighbors asked questions about the lighting of the project. The lighting is not allowed to throw light into adjacent properties. The proposed lights are all fully shielded to prevent lights from shining into neighboring property. The project is designed to produce zero light trespass.

Neighbors objected to the perceived noise associated with the facility. There would be very little noise from this facility. Kerry's employees use almost all electrical tools, they are easier and much quieter than compressed air tools. The air compressor is used to fill tires. However, that compressor is located inside its own room within the building. The wall facing your building is a solid, concrete masonry wall (you can think of it as an 8" thick slab of concrete between your property and the work). That said, we did place fake windows on the wall to give the building a warmer, more inviting feel. The entrance bays to get vehicles into and out of the building all face Mountain Side Fitness and not the residential properties to the north and east. While tow trucks may be in the area at night. The parking lot is set up to allow a tow truck to drop off a vehicle without backing up (by pulling through the parking stalls). Therefore, a tow truck would make no more noise than any other vehicle in the parking lot.

Neighbors objected to "toxic" chemicals at the project and requested they be provided with EPA approvals on all chemicals at the facility. The chemicals present at Kerry's Car Care are the same chemicals present in automobiles, such as the one you likely park at your house every day. All of these chemicals comply with EPA regulations for such use. Theses oils and coolants are only toxic if ingested. The chemicals are collected and

stored per the requirements of the Arizona Department of Environmental Quality and the EPA. Each chemical that is placed into vehicle in the country is cleared by the EPA and Department of Transportation prior to being allowed to be sold by the manufacturer or importer. The disposal of these items will not be at the dumpster, but by hazardous material disposal from containers stored inside the building until the disposal removal is scheduled as required by law.

Neighbors asked questions about the landscaping. The proposal has provided trees and shrubs along the east side of Kerry's building to soften the appearance of the building from the east. This will result in a more controlled and manicured look than neighbors currently have of the wall of Mountain Side Fitness.

Neighbors questioned the height of the building as being obtrusive. The building is shorter than the existing Mountain Side Fitness building and will within the height requirements of the zoning ordinance. Additionally, the elevation and landscaping we are proposing to face the adjacent residential lots is more developed, inviting and landscaped than the existing buildings.


