But, I want to make sure I really give you guys the best quality presentation because I do not intent to take this mural down. It is a mural about overcoming adversity. If I were to paint over it, it would giving in and giving up, and in the face of all thats going on in the world, in my business, in the community, I could never live with myself if I were to do that. I need a reminder and I think our community needs a reminder to keep on fighting right now.

Hello Mike,

Thank you for the photos. I have to be honest – that is *a lot* of mural – more than what I was expecting. It's beautiful, but we don't have any buildings or murals in Scottsdale that compares to how much building façade area your mural covers. Your mural will have to be reviewed and heard by the City's Development Review Board – which is a public hearing process. We are not able to review and approve your mural administratively, I am sorry to say.

The reason why you have to go in-front of the DRB is because your mural does not comply with the City's established Commercial Design Guidelines and Sensitive Design Principles. Refer to the attached Commercial Design Guidelines and scroll down to Pages 13 and 16 and go over the highlighted sections, and refer to the attached Sensitive Design Principles and go over the highlighted sections. The guidelines emphasize muted earth tones and warm neutrals as the dominant color of a building, and saturated colors should be used in very limited amounts.

The Development Review Board public hearing process normally takes anywhere between 2.5 to 3 months from the time you submit an application to the hearing itself. I cannot guarantee that your mural will be approved at the hearing – that is up for the Board to decide. Mario Alvarez with Code Enforcement can provide you with an extension from the June 7<sup>th</sup> deadline of the complaint to allow you the extra time to prepare for the hearing once you submit your Pre-Application.

If you do not want go through the public hearing process, you will have to repaint back the original colors of the building façade in the courtyard area and trellis features of the patio, and reduce the amount of mural area on the east elevation to probably 50% of the original size or less.

### PRE-APPLICATION

If you decide to go through the DRB process, then you will need to **submit a Pre-Application online by June 7<sup>th</sup>** to begin the process. Here is the link to the Pre-Application webpage to submit for Development Review:

You will need to upload the following documents in PDF format:

- Narrative/Scope of Work (PDF)
- Photos of each side of the building where you painted (PDF)
- Online Paint Samples of each color you used (PDF)

After you submit your application and pay the \$95.00 Pre-App Fee, you will be assigned a Pre-Application Number. In about 2 days, staff will email you acknowledging receipt of your submittal and who your assigned project coordinator is. You will then work with your coordinator and your coordinator will then provide you with a FORMAL application to submit (i.e. this is a 2-step process: submit the Pre-Application as Step 1, then submit your Formal Application as Step 2). Make sure to provide Mario Alvarez with your Pre-Application Number once you have it – that way Mario can track your case.

Thank you very much Mike. Let me know if you have any additional questions. Otherwise, please start working on your Pre-Application submittal paperwork and submit by June 7<sup>th</sup>.


