**Re: 7117 E. Indian School Rd. Scottsdale, AZ – Case Number: 63-PA-2020**

Dear Property Owner or Scottsdale Community Member,

Withey Morris, PLC represents PEG Companies (“PEG”) with regards to approximately 3.12 acres at or around 7117 East Indian School Road, which is located between 3rd Avenue and Indian School Road, near Marshall Way (the “Property”). See attached aerial map for your reference. The proposed mixed-use development for this site is a hotel and residential community, which will include ground level retail/restaurant space.

The site of this future development currently consists of three parcels and contains a Howard Johnson hotel, a 2-story office building, and an event center. The Property is currently zoned Central Business, Downtown Overlay (C-2, DO). PEG anticipates rezoning the Property to Downtown / Downtown Multiple Use Type-2, Planned Block Development, Downtown Overlay (D/DMU-2, PBD, DO). The proposed development is anticipated to consist of a 168-key AC Hotel by Marriott, which is expected to be 63 feet in height, a multi-family development, which is expected to be between 63 feet and 74 feet in height, and associated ground floor retail and restaurant uses. Attached is a preliminary site plan for reference.



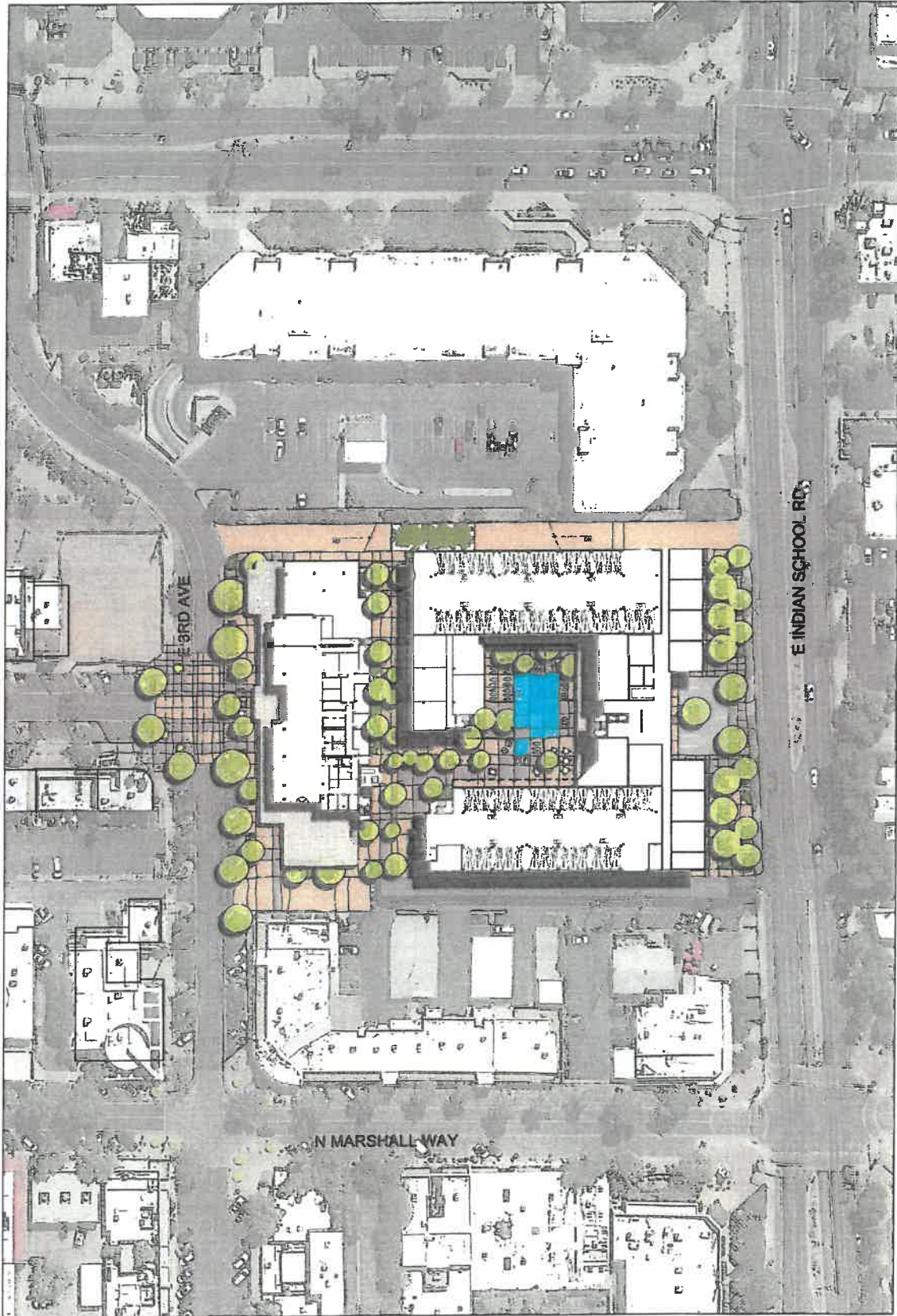
# Aerial Map
