Hello, as discussed at the pre-app yesterday below are the water/sewer items to address:

1. With this DR case review please have a FINAL combined water/sewer basis of design (BOD) report submitted as described per Ch6 and Ch7 of City DS&PM.

- 2. Per DS&PM BOD requires:
  - a. Seal by AZ PE
  - b. Demand estimates per DS&PM
  - c. Utility plan
  - d. Hydrant flow test
  - e. Determination of fire flow required (IFC and IBC) and fire flow available per hydrant test
    - i. Note: If this analysis is inconclusive modeling of the system may be required
- 3. Commercial and multifamily uses should have separate sewer service lines AND water service lines and meters.
  - a. 6" is minimum sewer service line sizing and should be per MAG 440-3. Locate perpendicular connection on downstream 1/3 of property frontage.
- 4. At current proposed site size and density no offsite water or sewer capacity analysis or modeling is required (except if fire flow requirement cannot be determined with high confidence)
- 5. Confirm best/required location of fire risers(room) and FDCs with fire plan review staff. Indicate this on the utility plan submitted with the BOD.

Please provide this email to your civil engineer to ensure submittal conformance.
