Project Proposal

The following documents citizen notification efforts for the Design Review application (DR) (#5-DR-2023) submitted for Fairmont Scottsdale Princess Resort.

Scottsdale Princess Resort plans to replace the existing surface parking spaces on the southeast corner of Princess Blvd and Princess Drive with a new parking structure. The new structure will consist of 3 levels and will provide 1100 public and valet parking spaces.

Notification Area Map

Attached is a map of the 750-foot buffer area within which all property owners were notified of the Design Review application to be filed. The city requires notification of property owners within 750 ft.

Dear Property Owner, Neighborhood Association, or Interested Party:

We are writing this letter to inform you that Fairmont Scottsdale Princess Resort (the “Princess Resort”) will be submitting a Development Review Board application with City of Scottsdale for a new parking structure on the resort property located at 7575 East Princess Drive (Case# 44-PA-2022). This new parking structure will replace the existing surface level parking on the southeast corner of Princess Blvd and Princess Drive and provide ample parking for the future conference center expansion and other proposed improvements to the Princess.

The structure will provide more than 1,000 self and valet parking spaces on two elevated levels and one basement level (relative to Princess Boulevard) served by three guest elevators. The structure will be an open – non-mechanically ventilated – cast-in-place concrete structure with a stucco style, color, and articulation similar to the main buildings of the Princess Resort.
