The purpose of this memorandum is to summarize the results of the FAA Height Analysis for the Toll at Cavasson Development's proposed buildings. It was found on all 44 of the proposed building groupings that there was No Hazard to Air Navigation. It should be noted that FAA Form 7460-2 will be required to be e-filed any time the project is abandoned or as noted on the individual determination letters. 



However, this equipment shall not exceed the overall heights as indicated above. Equipment which has a height greater than the studied structure requires separate notice to the FAA.

This determination concerns the effect of this structure on the safe and efficient use of navigable airspace by aircraft and does not relieve the sponsor of compliance responsibilities relating to any law, ordinance, or regulation of any Federal, State, or local government body.
