29 within the SILVERLEAF Development, located on at 18622 North 101st Street,

in Scottsdale, Maricopa County, Arizona 85255.

In accordance with your request and authorization, Geotechnical Testing & Inspections (GTI) has completed the special inspection services related to the placement of anchor bolts and epoxied threaded rods at the subject site.

On July 13, 2021, a GTI special inspector visited the subject site and conducted a visual inspection of the placement of the anchor bolts and epoxied threaded rods. Forty-seven (47) #6 Titen anchor bolts were mechanically embedded within the concrete slab foundation. In addition, twenty-six (26) 5/8-inch by 16-inch diameter threaded rods, each with an HTT5 bracket, were embedded into clead/drilled holes within the concrete slab foundation and set using Set-XP epoxy (Expires December 11, 2021). A total of seventy-three (73) anchors and rods were installed at this location.

The placement of all the anchors and threaded rods were in compliance with Simpson specifications for this type of installation.
