Comment:	<p>RE: COS HPC virtual meeting of July 9th, 2020: I watched this meeting on Ch. 11. Concerning the discussion of Agenda Item #4 on July 9th, Roman Townhouse Driveway Pavers, which was approved; the staff report noted that 35 driveways in VM Units 2-5 had already been changed over to pavers. Commissioner Hausner opined that if the HPC was going to continue to approve installation of driveway pavers then provision should be made for that in the draft Historic Preservation Plan and Guidelines for Villa Monterey Units 1-7 Historic Guidelines. Other Commissioners seemed to agree. Please advise the HP Commission that installing driveway pavers is already in the current draft plan, specifically in the Appendices for Units 3, 4, and 5. And the draft plan of January 2018 notes in Chp. 8 A that "Numerous townhouse owners have.... installed decorative unit pavers or stone pavers." Also, the revised and edited draft plan that was submitted around May 1st, 2020 by Villa Monterey representatives notes in Chapter 8 that many driveways have already been replaced or modified.
