Sorry I haven't been able to get back to you yet.

As you are probably aware, Mr. Leary sent several questions and comments about the City's Abandonment Valuation Procedure (AVP) to Management separate from the AB and ZN cases. I'm Real Estate's point person for the program so I've been responding to internal requests, researching data, and meeting with staff about the program over the last few weeks. After preliminary internal discussion, Management asked me to focus my efforts on reviewing and proposing updates to the AVP, and other related portions of the program, before I proceed with writing the scope of work for the appraisal of the GLOs in this AB case because it is likely that my team will be recommending changes to the AVP.

Unfortunately, I don't have a resolution timeline yet on this task. I did meet with my immediate supervisors this past Friday to present my team's research and obtain feedback. I need to gather, review, and summarize some more data and then I hope to be able to draft my team's recommendation for review.

I will touch base with an update on my progress at the end of this week.
