CITIZEN & NEIGHBORHOOD INVOLVEMENT REPORT

This Citizen Participation Report is in association with the request (797-PA-2024) to rezone approximately 40 acres (APN: 217-01-007B & H) at the southeast corner of Ranch Gate Road & 128th Street. This subject site is surrounded by an approved 462-acre residential master plan known as Storyrock (13-ZN-2014), which was approved by the City of Scottsdale back in 2014. The rezoning of this +/-40 acres, not originally apart of the surrounding Storyrock approvals, from R1-130 ESL to R1-35 ESL will allow for a consistent single-family residential land use within the overall Storyrock development. The proposed thirty-three (33) residential lots (0.83 du/ac) are consistent with the surrounding area and the City of Scottsdale General Plan land use designation of rural neighborhoods, which allows up to one (1) du/ac (Maximum 40 lots).

In accordance with the requirements for this application, a notification letter is being sent on December 13th, 2024 to interested parties, neighbors and property owners within 1,250 feet of the site . The letter includes information about the project and contact information for the project consultants and City staff to allow recipients the opportunity to directly express any questions and/or concerns. The letter also included an invitation to a neighborhood meeting where surrounding property owners and interested parties will have the chance to learn more about the project. The meeting is scheduled at Living Water Lutheran Church on January 9, 2025 at 5:30 pm.

In addition to the notification letter, a sign will be posted on the site to further notify residents and passersby of the rezoning application and associated neighborhood meeting.

The project team realizes the importance that all citizen outreach and input plays in the development process. We are committed to encouraging and allowing residents and neighbors to express their thoughts, help them understand the matters and attempt to address them in a professional and appropriate way.
