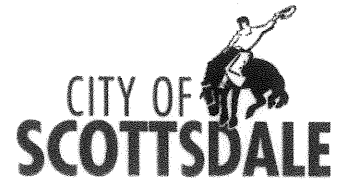



- History: In 2006, this location was a restaurant called Sol Y Sombra.

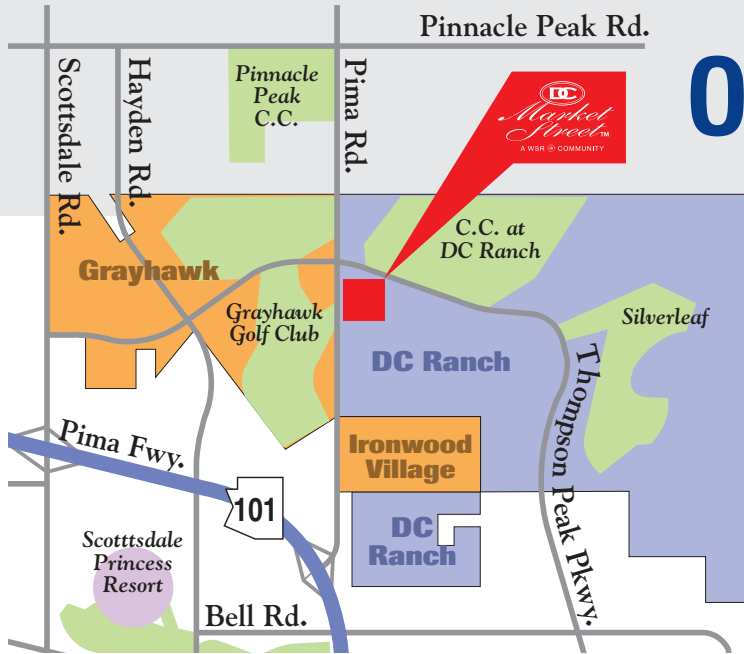
