There will be a Development Review Board meeting to review this submittal and receive public comment at some point in the near future. The property will be posted by the City with the time, date and location of this public meeting.

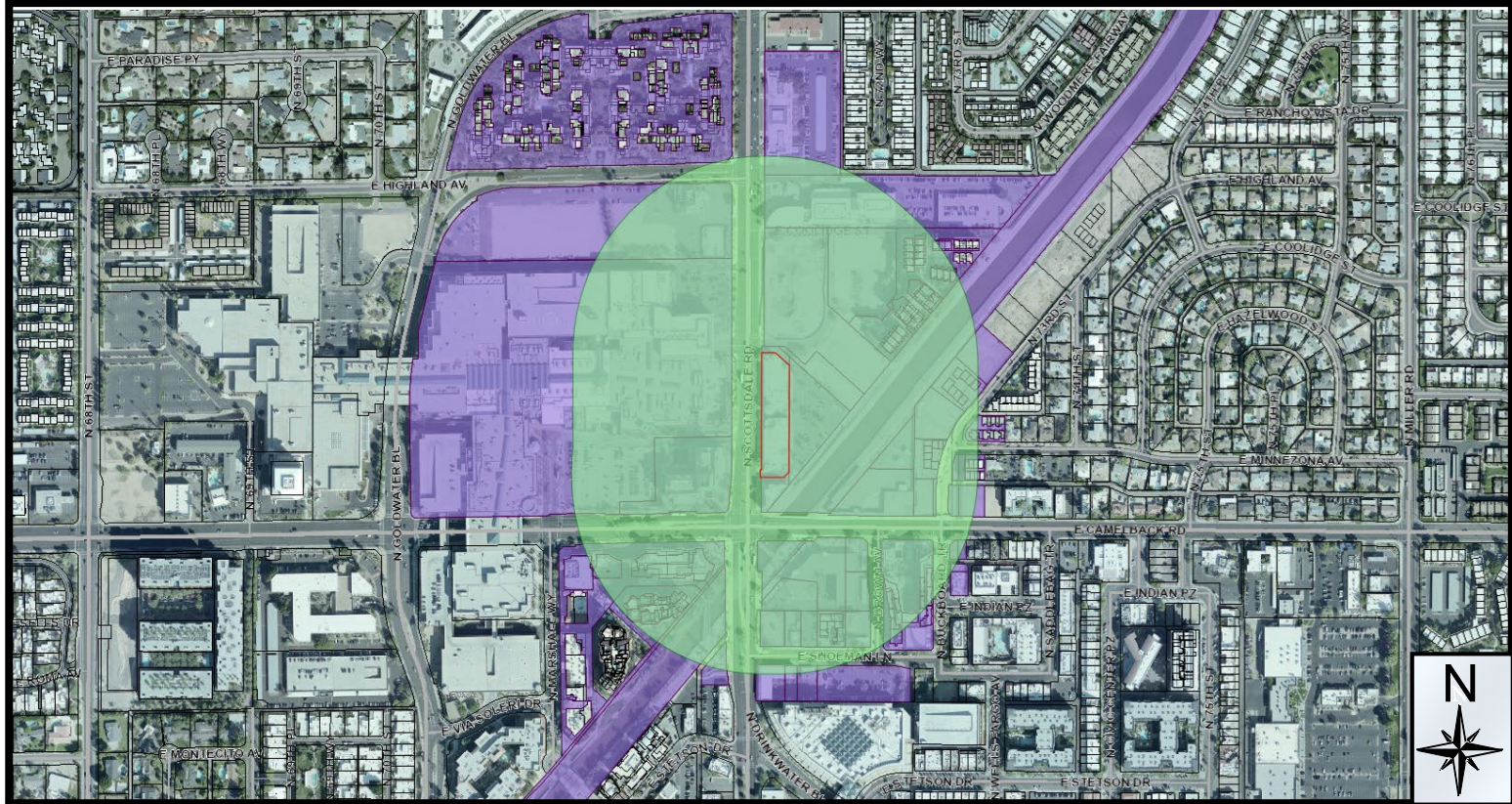

Renaissance Facade Renovations




Surrounding property owners within 750 feet of the currently existing Renaissance Scottsdale retail center were contacted on June 21, 2019 via first class mail to discuss the upcoming Development Review for the facade renovations of the two buildings located north of the northwest corner of Scottsdale Road and Camelback Road. Neighbors were informed that the improvement plans were being submitted for review at an upcoming DRB meeting and that the City would post the site with the meeting time, date and location. Additionally, they were given contact information for the outreach team as well as the City's Project Coordinator if they had questions or concerns.

The outreach team for Renaissance Scottsdale is committed to the outreach process and informing people of all phases of the project. 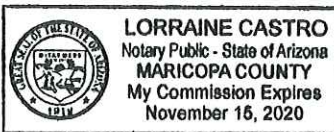
