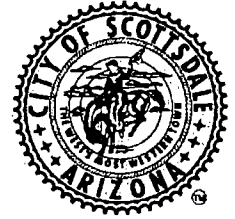


# CITY COUNCIL REPORT



Meeting Date: August 20, 2024  
 General Plan Element: *Public Services & Facilities*  
 General Plan Goal: *Provide a safe environment for all citizens, visitors and private interests*

## **ACTION**

**Ordinance No. 4644.** Adopt Ordinance No. 4644 amending Section 19-21 of the Scottsdale Revise Code regarding camping in public places.

## **BACKGROUND**

In *City of Grants Pass, Oregon v. Johnson*, the US Supreme Court recently held that the City of Grants Pass's public camping ordinance did not amount to criminalization of a status (i.e., being homeless), so it was not prohibited by the US Constitution's Eighth Amendment Clause banning cruel and unusual punishment. Additionally, the Court ruled that the fines and jail time allowed by the ordinance are not considered heinous or unusual. Thus, the 8th Amendment's cruel and unusual punishment clause does not prohibit the City of Grant Pass' from passing and enforcing laws addressing public camping. As a result, the holding in *Martin v. City of Boise*, 920 F.3d 584 (2019) that people should not be criminalized merely because they are homeless has been called into doubt and is likely no longer applicable and that public camping ordinances could generally only be enforced when shelter space was available. Proposed Ordinance No. 4644 amends Section 19-21 of the Scottsdale Revised Code by removing the requirement that shelter space must be available before enforcing Scottsdale's ordinance on camping in public places. The ordinance will still contain a provision that requires an opportunity for the impacted person to be given a reasonable opportunity to relocate prior to be arrested or cited.

## **ANALYSIS & ASSESSMENT**

The principal proposed provision amending the camping in public places ordinance is a provision striking references to available shelter space. The ordinance will no longer require there be shelter space available prior to enforcement but will require that a violator be given a reasonable opportunity to relocate prior to being arrested or cited.

In the event the City Council passes the proposed ordinance, City Human Services staff will work to conduct outreach prior to any enforcement to homeless people impacted by this ordinance to help offer them resources.



ORDINANCE NO. 4644

AN ORDINANCE OF THE COUNCIL OF THE CITY OF SCOTTSDALE,  
MARICOPA COUNTY, ARIZONA, AMENDING SECTION 19-21 OF THE  
SCOTTSDALE REVISED CODE

BE IT ORDAINED by the Council of the City of Scottsdale, Maricopa County, Arizona, as follows:

Section 1. Scottsdale Revised Code Section 19-21 is hereby amended, as follows with new language shown in shaded format and deleted language in strikethrough format:

**19-21. – Camping in public places.**

(a) The following words, terms and phrases, when used in this section shall have the meanings ascribed to them below except where the context clearly indicates a different meaning:

*Camp* means to reside in or use a public park, public street, the McDowell Sonoran Preserve or other public place for living accommodation purposes; including, but not limited to, activities such as erecting tents or any other structure providing shelter, digging or breaking earth, laying down bedding for the purposes of sleeping, using camp paraphernalia, storing personal belongings, starting a fire, regularly cooking or preparing meals, or living in a parked vehicle.

*Camp paraphernalia* includes, but is not limited to, tarpaulins, cots, beds, sleeping bags, hammocks or non-city designated cooking facilities and similar equipment.

*Public park* means all city parks and playgrounds.

*Public street* means all public streets and highways, public sidewalks, public benches, public parking lots and public parking structures.

*Public place* means publicly owned property including, but not limited to, the Scottsdale Civic Center, transportation facilities, schools, attractions, monuments and any improved or unimproved public area.

~~*Shelter space* includes, but is not limited to, a vacancy at a homeless shelter, hotel or motel contracted by the city to provide housing for homeless individuals, or other similar facility.~~

(b) No person shall camp in any public park, the McDowell Sonoran Preserve, public street or public place, except when specifically authorized by a permit issued by the city.

(c) A violation of this section is a class 3 misdemeanor.

(d) Prior to issuing a citation or making an arrest for this section, a peace officer shall give a person violating this section a reasonable opportunity to relocate ~~and shall also confirm that there is available shelter space.~~
