#### **BACKGROUND**

The Via Linda Road Community Facilities District (District) was formed in 1998 to facilitate the financing, acquisition, and construction of public infrastructure within the District. To date, \$3,225,000 of tax-exempt bonds were issued and will be paid in full on July 15, 2023. The District will continue to exist until the earlier of five years with no activity (excluding administrative costs) or dissolution by the voters of the district.

The District was responsible for the installation of infrastructure, which benefits existing and future residents of the District and the City. The District will pay all debt service requirements on July15, 2023 on the bonds and therefore a tax assessment is no longer necessary.

The FY 2023/24 proposed budget (see Exhibit A of Attachment #1) has been prepared pursuant to the requirements of the Arizona Revised Statutes. The first Resolution calls for approval of the proposed budget and a public hearing on the proposed budget and the second Resolution adopts the budget subsequent to the hearing (see Exhibit B of Attachment #2).

#### FISCAL IMPACT

The District will satisfy all debt service requirements on July 15, 2023 and will no longer levy taxes from the District property owners. The proposed budget is for the District's ongoing administration expenses, paid from fund balance, until dissolution of the District




