RE: Item 14B, Repeal of the Scottsdale Community Sustainability Plan and Establishing a Sustainability Task Force

Pursuant to the 2024 Rules of Council Procedure Rule 6.12, Item 14B (Repeal of the Scottsdale Community Sustainability Plan and Establishing a Sustainability Task Force) was added to the January 14, 2025 Regular Council Meeting agenda at the request of four or more members of the City Council.

Item 14B requests the Council consider adopting **Resolution No. 13335** (attached), which would repeal Resolution No. 13308, which approved the Scottsdale Community Sustainability Plan. If approved, **Resolution No. 13335** would also direct the Interim City Manager to establish a Sustainability Task Force to look at the long-term sustainability of the City by examining fiscal, population, and conservation needs.

RESOLUTION NO. 13335

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SCOTTSDALE, MARICOPA COUNTY, ARIZONA, REPEALING RESOLUTION NO. 13308 AND THE SCOTTSDALE COMMUNITY SUSTAINABILITY PLAN AND DIRECTING THE INTERIM CITY MANAGER TO WORK TO ESTABLISH A SUSTAINABILITY TASK FORCE TO LOOK AT THE LONG-TERM SUSTAINABILITY OF THE CITY BY EXAMINING FISCAL, POPULATION AND CONSERVATION NEEDS.

WHEREAS, the Council finds it is in the best interest of the City to repeal the Scottsdale Community Sustainability Plan; and

WHEREAS, the Council finds that it is in the best interest of the City to create a Community Sustainability Task Force to look at the long-term sustainability of the City by examining the fiscal, population and conservation needs;

NOW, THEREFORE BE IT RESOLVED by the City Council of the City of Scottsdale, Maricopa County, Arizona, as follows;

Section 1. That Resolution No. 13308 and the Scottsdale Community Sustainability Plan is hereby repealed and the City Council further directs the interim City Manager to work to establish a Community Sustainability Task Force to look at the long-term sustainability of the City by examining the fiscal, population and conservation needs.


