### Trinity Church Fall Festival 2024

### **Security/Usher/Parking Lot/First-Aid:**

This team will be led by our Director of Security and supported by other staff members of the church. All teams will meet 30 minutes prior to the start of the event. All members will be on radio and in communication throughout the event. After the main room clears, we will move additional security personnel to the outdoor areas. Each ride will have a security volunteer.

### Security

7 Security members and 3 off-duty officers with radio communications for our Church and Easter Service and traffic flow in and out of the parking lots.

#### **Ushers**

4 Ushers will be working this event.

2 Ushers will be posted on each side of the main room.

Ushers will help with seating as well as any evacuation needs.

### First Aid/CPR/Medical Responders

We have CPR/AED/First Aid certified staff and volunteers.

### **AED/FA Kits**

We have 2 on-site AEDs that are up-to-date and deployed to our main room. One is marked by signage in the southeast corner near the exit. The other will be carried in our volunteer's FA kit.

### **Parking Plan**

We will have 6 parking lot team members and 1 off-duty officer per service to guide and direct traffic. Their responsibilities will be to safely load the parking lots until full and then direct additional/overflow vehicles to the designated areas located across the street. To avoid attendees from parking in the neighborhoods and along the streets, we will place "No Church Parking" signs along the nearby streets (86th street/Berridge Lane/Rovey Ave). We will also have our parking lot crew monitoring and directing away from these streets and to the overflow lot near the Trinity Café. The Green boxes are where we can send overflow parking for the event. The Red box and everything west of these spots are not authorized. We will have a parking lot crew member over in this area directing to the appropriate spaces. There are over 100 spaces in our overflow lots.
