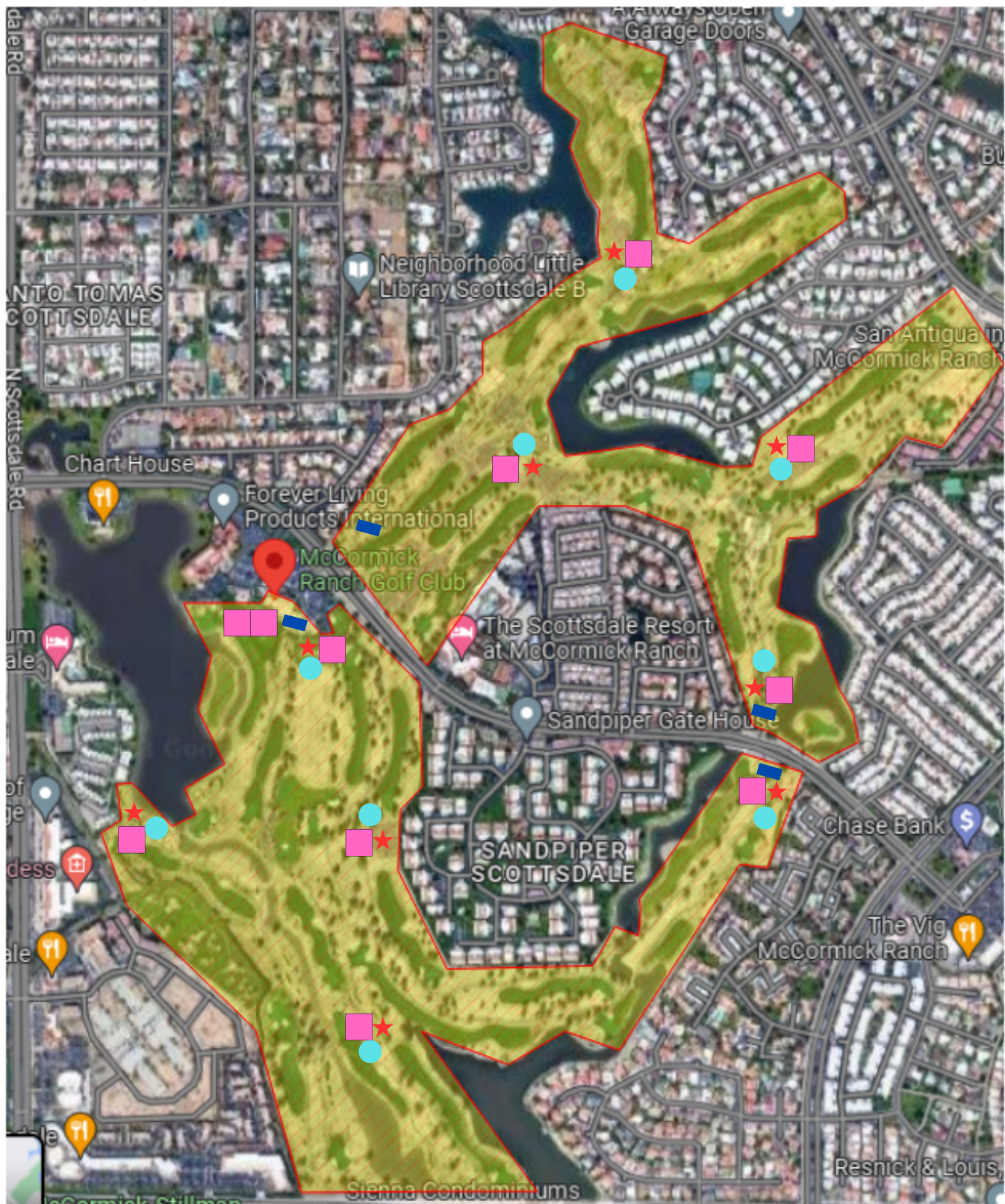

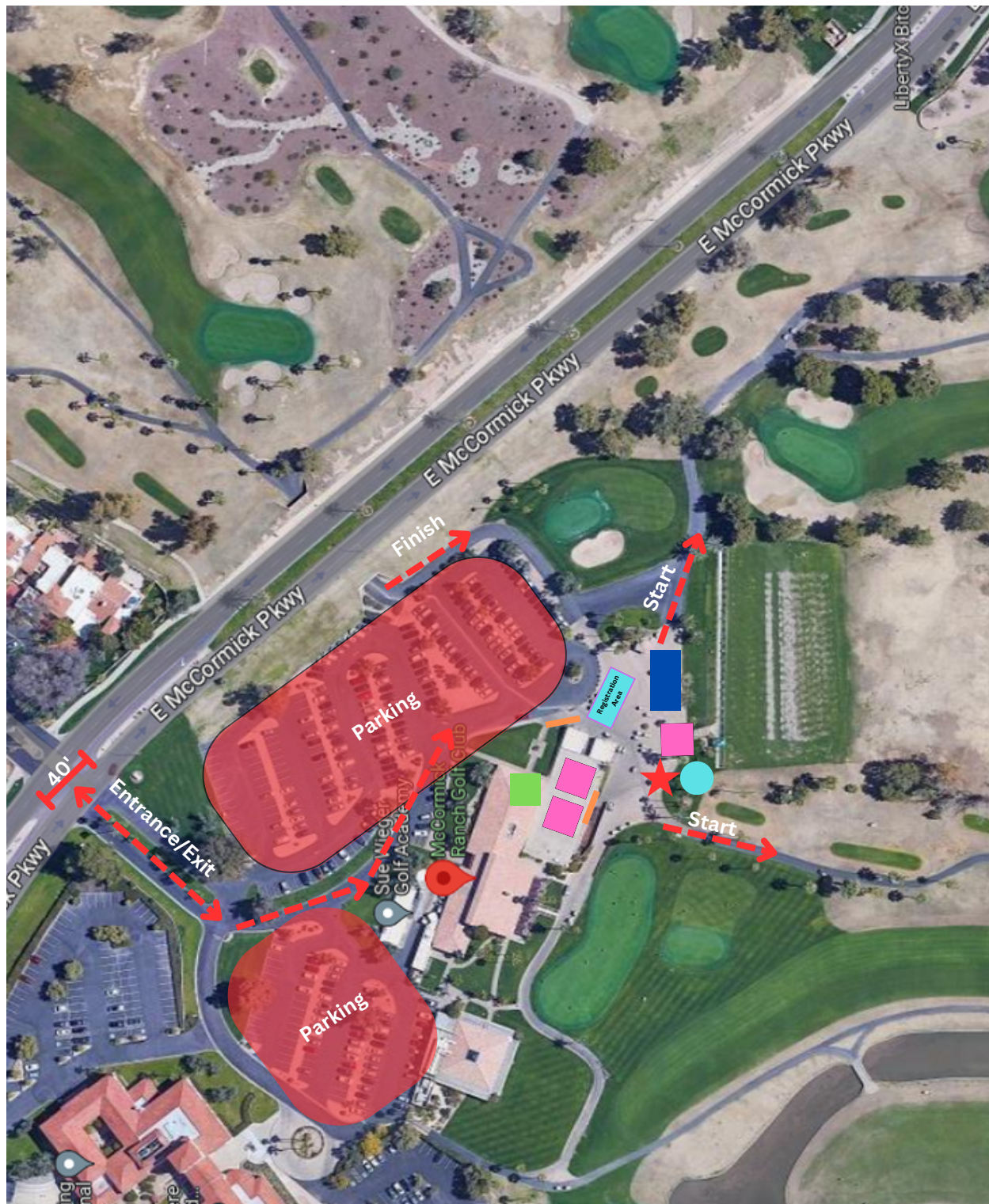

Overview of Site Plan

The intent is to show the area where the tournament will be held and where we would like to hold the license. Since this is such a big area, we have shown the entire golf course along with close up club house areas where parking and check-in/Registration will be held. The bar holes on the course will include 2 bars for every 9 Holes. Being (2) 18 hole courses we have a total of 8 Bars going on the golf course. Then one bar will be at Registration only open till 11am when the shotgun start occurs for the tournament.

The entrance to the event will be at the main entrance of the golf course. Once the tournament starts, golfer will spread to a separate hole on the golf course (Shotgun Start). All Participants will end their day at the Golf Cart return area at the club house. All Participant will be parking onsite in the Golf Course parking lot.
