Park Neighborhood Entry Monuments and Landscape Enhancement

This memorandum presents a community request to the Neighborhood Advisory Commission, for Neighborhood Enhancement Grant Program (NEGP) funding to repaint and provide limited landscape enhancements to the existing neighborhood entry monuments within the Sherwood Heights and Fairway Park neighborhoods along East Thomas Road, North 56<sup>th</sup> Street, and East Oak Street.

#### **BACKGROUND**

The Neighborhood Advisory Commission annually operates the Neighborhood Enhancement Grant Program with City Council approved budget funding for neighborhood improvements as a means to implement the purpose, powers, and duties of the Commission, pursuant to Ordinance 4331 (included as Enclosure 1), and without creating conflicts with the City Charter (Section.3. Powers of the City. O.).

For the 2022/23 fiscal year, the Neighborhood Advisory Commission has a City Council approved budget of \$30,000 available to provide for neighborhood improvements.

#### **NEIGHBORHOOD ENHANCMENT GRANT PROGRAM REQUEST**

The request for Neighborhood Enhancement Grant Program funding (Enclosure 2) for the Sherwood Heights and Fairway Park neighborhoods was received in June 2022, requesting:

- 1. Neighborhood Signage, and
- 2. Landscape Enhancement

The applicant's request cites that the two neighborhoods have a total of fourteen (14) existing sign monuments – ten (10) of which include areas designated for desert-type plantings that do not provide irrigation (Enclosure 3). Previously, barrel cacti and low water plantings were included in these areas; however, it was an onerous effort on the neighborhood to hand-water to keep the plantings alive, thus the plantings have been removed.

Accordingly, the project scope of work (Enclosure 3) is to repaint (to match existing) the existing planters and the associated neighborhood signage monuments at the entrances of East Thomas Road (1 location), North 56<sup>th</sup> Street (4 locations), and East Oak Street (2 locations). The applicant proposes to locate artistic metal representations of agaves and pricky-pear cacti within the monument planter areas; the artistic metal representations of agaves and pricky-pear cacti will be purchased by the neighborhood (a \$6,772 investment) and are not part of this request.

The following program criteria and requirements have been met:

- Location & Accessibility (Requirement) Portions of the project meet this requirement
  as 3 of the locations (two monuments at each location) are within city right-of-way and
  have frontage along East Thomas Road and East Oak Street, public streets that are
  classified as a Minor Collector or greater in size. The remaining 4 locations do not meet
  this requirement as North 56th Street is not an NEGP-qualifying public street it is
  located outside of Scottsdale (City of Phoenix) and does not have a street classification
  in Scottsdale's Transportation Action Plan. However, the Commission should note that:
  - All 7 locations do contribute to the overall enhancement of the neighborhoods, while also meeting other requirements and considerations for NEGP funding;
  - All 7 locations are associated with the same neighborhoods, are in locations that can be seen by the public, and adjacent to non-HOA Neighborhoods where existing funding mechanisms are not available;
  - o All 7 locations are located within City of Scottsdale right-of-way; and,
  - All 7 locations are adjacent to pavement that is maintained by City of Scottsdale staff.
  - Although the City of Phoenix, notes the 56<sup>th</sup> Street as an unclassified street, City of Scottsdale Transportation Staff have stated that if 56<sup>th</sup> Street, a mile street, was located within Scottsdale's jurisdictional boundary it may be classified as a Minor Collector street; however, additional data would be needed to determine it as such.
- General Need (Requirement) –Sherwood Heights and Fairway Park do not have formal homeowner associations that allow for the regular collection of funding to maintain the subject areas of this application. The existing monument locations were originally developed in the 1950's prior to city annexation. The subject monuments now exist at the edge of the city's right of way, based on aerial verification, and as a result of such annexation. To date, the community has maintained the signs without assistance from the city. The application cites that the monuments were last painted in 2010. To achieve the neighborhood's desired objective, NEGP funding would allow the neighborhood to promote a consistent visual character of the neighborhood, without requiring the neighborhood to maintain landscape areas that do not have irrigation available.
- Existing Conditions (Consideration) The subject monuments have paint that has faded and is lacking the provision of landscaping.
- Maintenance (Consideration) The project site does not have an active "Notice of Compliance" from Code Enforcement.

Based on NEGP criterion, and the staff analysis of the request provided above, staff has prepared two options for the Commission to consider. In coordination with community members, estimates have been provided with the application. For clarity, a breakdown of estimates for the various aspects of the request have been provided, below:

- Option 1: 7 monument locations (14 signs total), along East Thomas Road (1 location), North 56<sup>th</sup> Street (4 locations all within City of Scottsdale rights-of-way but not a classified Minor Collector Street), and East Oak Street (2 locations):
  - o \$5,200 purchase and application of paint on all monument signs
  - \$5,050 Installation of artistic metal representations of agaves and pricky-pear cacti
  - o Total: \$10,250
- Option 2: 3 monument locations (6 signs total), along East Thomas Road (1 location) and East Oak Street (2 locations) only, (the North 56<sup>th</sup> Street locations are eliminated with this option):
  - \$2,000 purchase and application of paint on all monument signs
  - \$2,000 Installation of artistic metal representations of agaves and pricky-pear cacti
  - o Total: \$4,000

If approved, improvements will be paid by the requested NEGP funds subject to city purchasing guidelines and requirements. On-going maintenance will be the responsibility of the adjacent property owners.

#### STAFF RECCOMENDATION, DISCUSSION, AND POSSIBLE ACTION

The original request for NEGP funding included the costs associated with the purchase of artistic metal representations of agaves and pricky-pear cacti within the monument planter areas which totaled an additional \$6,772.00 to the original request. However, since the original request was made, the request has been amended with a commitment from the Sherwood Heights and Fairway Park neighborhoods to the purchase of these items – proving themselves as a partner in maintaining and enhancing their neighborhood. Although 56<sup>th</sup> Street is not a classified Minor Collector, approving this request will allow a consistent design theme among all monuments thus reinforcing the character of the neighborhood. Finally, by sharing in the overall cost of the project, this will allow other Scottsdale neighborhoods to make application for any remaining NEGP funding available this fiscal year.

Consequently, staff recommends the following:

1) Approval of Option 1, the request for NEGP funding for Sherwood Heights and Fairway Park neighborhoods community monument sign repainting and landscape enhancement at 7 monument locations (14 signs total), along East Thomas Road (1 location), North 56<sup>th</sup> Street (4 locations), and East Oak Street (2 locations), in an amount not to exceed \$10,250, or

#### **ORDINANCE NO. 4331**

AN ORDINANCE OF THE CITY OF SCOTTSDALE, MARICOPA COUNTY, ARIZONA, AMENDING SECTIONS 2-322 AND 2-323 OF THE SCOTTSDALE REVISED CODE PERTAINING TO THE NEIGHBORHOOD ADVISORY COMMISSION

BE IT ORDAINED by the Council of the City of Scottsdale as follows:

<u>Section 1</u>. Sections 2-322 and 2-323 of the Scottsdale Revised Code pertaining to the Neighborhood Advisory Commission is amended as follows:

Section 2-322. Membership.

The Neighborhood Advisory Commission shall consist of seven (7) members, each of whom shall be appointed by the city council. The term of each member shall be for three (3) years, except the terms of those members who were current members of the Scottsdale Neighborhood Enhancement Commission or Housing Board at the time of the enactment of this division shall expire on the date that their term would have expired for their respective prior commission or board. The initial membership of the commission shall consist of the membership of the Housing Board and Neighborhood Enhancement Commission at the time of adoption of this division. The membership shall be reduced to seven members through attrition by resignation or expiration of term.

Section 2-323. Purpose; powers and duties.

- (a) The purpose of the Neighborhood Advisory Commission is to advise and make recommendations to the city council on policies, plans, strategies and programs for the preservation, improvement and revitalization of Scottsdale's housing and neighborhoods. The commission may advise and make recommendations on other issues and matters as the city council may direct. The commission may make recommendations to other city boards and commissions, in accordance with the commission's purpose.
- (b) In accordance with City Council Resolution Number 8929 approve or disapprove applications made pursuant to the R1-7 Residential Exterior Enhancement Program.
- (b) The commission shall establish criteria for determining how Neighborhood Enhancement Grant Funds are allocated. Any required application shall be filed with the city.

(c) The commission shall approve or deny Neighborhood Enhancement Grant Program applications pursuant to the application procedure and established criteria.

Project: Sherwood Heights & Fairway Park Signage & Landscape Improvements Goal: To revitalize the entrance signage and planters located at the street entrances to the subdivisions.

#### **Project Description:**

Repaint existing planters and the associated signage to provide a more pleasing and aesthetic appearance at the street entrances to the neighborhoods from East Thomas Road, North 56th Street, and East Oak Street. Old landscaping plants are to be removed and replaced with painted metal agaves and prickly-pear cacti designed and installed by artists currently living in the neighborhood.

Background:

The Sherwood Heights & Fairway Park Neighborhood Association (SH&FPNA) is an organized group of neighbors residing in four subdivisions sharing a boundary, as follows:

- Sherwood Heights
- Sherwood Estates
- Fairway Park
- Heritage East

These subdivisions are located in southwest Scottsdale between Thomas Road on the north, 62nd Street on the east, Oak Street on the south, and 56th Street on the West. Historically, the four subdivisions have occupied the "West's Most Western City's" most western area since annexation in the 1960's.

The City of Scottsdale has considered the neighborhood to be an important part of the City's development and, as such, initiated the "Sherwood Heights Area Neighborhood Plan" in 2002. The resulting study was intended to be used as "a tool to maintain and enhance the vitality and character of the existing neighborhood."

History of the SH&FPNA:

Neighborhood Character and Identity:

Since their initial development the entrance signage planters on Thomas Road, Oak and 56th Streets have been an integral part of the identity of the neighborhood. Over the years the Neighborhood Association has funded the maintenance and upkeep of the signage and the care and hand watering of the plantings. Lately, there has been a decision to update the planters with artistic metal representations of agaves and prickly pear cacti to eliminate the need for hand watering while keeping the western theme. Moreover, the intent to save the cost of watering for environmental conservation was an added consideration.

Illustrations of the proposed metal plant sculptures is attached.

**Physical Description** 

Sherwood Heights is a single family residential neighborhood located on 79 acres in Scottsdale, Arizona. The neighborhood is at the City's western boundary adjacent to Phoenix, between 56<sup>th</sup> and 60<sup>th</sup> Streets. Wilshire Drive marks its northern boundary and Oak Street is the southern boundary. Sherwood Heights is comprised of three subdivision plats, with 117 single family detached homes. The street pattern in the neighborhood is curvilinear with a gently rolling topography. The paved streets have rolled curb gutters and lack sidewalks. Lots are rectilinear and pie shapes and average one half an acre with natural desert landscaping. A number of different house plans and designs are present in Sherwood Heights. Most of the homes are constructed with block walls, though several are made with adobe, brick, or slump block. A variety of roof materials are found including asphalt and wood shingles, cement tiles and built-up materials as well as asbestos shingles and clay tile. This range of design and materials gives a heterogeneous appearance to the development.

#### History

The area that includes Sherwood Heights was reportedly a County trash dump before being developed as a residential neighborhood. In 1955 Phoenix Title and Trust recorded three residential subdivision plats on the site, which were approved by the Maricopa County Board of Supervisors that same year. The area subsequently became part of an annexation war between the cities of Phoenix and Scottsdale, which originally began in the mid 1950s and continued back and forth until the early 1960s.

New home construction began in the Sherwood Heights neighborhood almost immediately after the site was subdivided in 1955. Most of the homes were built between 1955 and 1965, with a median construction year of 1959. One home was built later, in 1974. When it first opened, Sherwood Heights was one of six developments under construction simultaneously in the northeast Valley by D.D. Castleberry, a local builder who specialized in upscale and custom homes. By the late 1950s Castleberry had begun development of five additional neighborhoods in the northeast and east Valley. Within the immediate area of Sherwood Heights, Castleberry also developed the Sherwood Towne neighborhood at the northwest corner of Thomas Road and 56<sup>th</sup> Street as well as Sherwood Estates, which was just east of Sherwood Heights at 60<sup>th</sup> Street. In the fall of 1956, Castleberry also designed, planned and constructed a retail complex known as the Sherwood Towne Center to serve the new residents of his residential developments. The shopping center is located on Thomas Road, east of 56<sup>th</sup> Street and originally included an A.J. Bayless Market as well as a pharmacy, variety store, launderette, beauty salon, and barber shop. The center also contained Castleberry's office. In 1958 Castleberry constructed larger quarters for his firm on Thomas Road, east of the Cross Cut Canal, where he included a decorator sample room for tiles, wallpaper, paints, etc. and private offices for his residential and commercial building superintendents.

Castleberry promoted his new upscale residential development with large ads that he published in local newspapers and in *The Arizonian*. To assist in marketing Sherwood Heights he also constructed an entry feature for the neighborhood and built several model homes on speculation, which were "tastefully furnished" and professionally decorated. The homes in Sherwood Heights sold for \$18,000 and up and were among the most expensive of all his developments. In an effort to distinguish his product from the mass produced tract home, Castleberry offered buyers in Sherwood Heights and his other developments their choice of 17 different plans or a "custom-designed, custom-crafted" home. The models were named after English towns and estates and included the Buckingham, Windsor, Oxford, and Camelot. Castleberry boasted that his homes were "individually blended proudly on their estate-sized lots" to reflect "quality and prestige". The location of Sherwood Heights with views of Papago Park and Camelback and its "picturesque desert lots" were also promoted as amenities. In the fall of 1956, Castleberry constructed an electric demonstration home in Sherwood Heights, in partnership with the Salt River Power District. The home was designed by the architectural firm Allan and Olsson. It was one of 23 such homes in the nation and was featured in *Living for Young Homemakers* Magazine. 4,500 people toured the electri-living home the first day it opened and it sold that same day.

#### Significance

Sherwood Heights is significant for its representation of post World War II single family residential subdivision practices in Scottsdale, Arizona. It is also important for its distinctive range of postwar, modern architectural styles. The proposed district has a high degree of integrity, with 84 percent of the homes contributing to its

Sherwood Heights is an excellent example of a large-scale development with upscale, semi-custom and custom homes. This character is reflected by its prestigious location overlooking Papago Park, within view of Camelback Mountain, and near the Arizona Country Club. In addition, the physical attributes of the neighborhood, including its hilly topography, curvilinear streets, individually sited homes, and large desert lots with varied rectilinear and

pie shapes convey its association with upscale residential subdivision patterns. Enclosure 2 for Agenda Item 4 the homes are also reflective of semi-custom and custom construction patterns, with large homes that average 2,100 square feet and two bathrooms. The variety of plans and range of wall and roof materials provide Sherwood Heights with a heterogeneous appearance, which also helps convey its association with custom home building practices.

Several different Ranch and Contemporary architectural styles from the late 1950s and early 1960s are also illustrated in Sherwood Heights. These styles include Simple and California Ranch designs as well as an assortment of Contemporary influenced models. The use of different designs and modern architectural styles help convey the neighborhood's association with the practice of upscale and custom home development in the postwar period.






